Learning to WRAP

In April, three staff members from WCGRH joined representatives from all other state hospitals in Milledgeville, GA to get their first taste of Wellness Recovery Action Plans (WRAP). Anna-Marie Houin, Carnell Greenfield and Heather Smith attended the two-day seminar provided by the Copeland Center to introduce state employees to the concept of WRAP—a wellness tool developed by Mary Ellen Copeland that is used around the world by those seeking a way to take control of their own recovery and wellness. WRAP isn't just for individuals in the hospital—it's for anyone wanting to pursue wellness on a daily basis.

Heather Smith tells us about the experience...

"WRAP has been a buzzword in the state system for some time now but this is the first 'official' training for WRAP to be implemented statewide. We learned a great deal about WRAP and about ourselves in that first training and were grateful to go back again in May for a five-day facilitator training. During this training, we broke down each element of WRAP (key concepts, wellness toolbox, daily maintenance, triggers, when things are breaking down, crisis and post crisis) and learned how to incorporate a variety of facilitator skills to share this information with others.

We are so excited to bring our new skills to the hospital and we're already coming up with creative and 'out of the box' ways to share what we've learned with everyone here at WCGRH. Stay tuned for more information about your own opportunities to learn about and use WRAP for your personal wellness!"

The RESPECT Committee Member Spotlight **Hannelore Perkins**

Tell us about yourself and your career here at West Central.

I was born in a small city in Germany. From the time of my birth to the age of 7 or 8, I lived in numerous orphanages. In those institutions, I was no one. No one spent time with me. No one talked to me. No one instilled hope in me. After age 8, I went to live with my grandmother and then at age 10, sent to live with my mother, whom I did not know. At 14, I found myself in the US with my mother, stepfather and my brother. We returned to Germany as a family but in 1982 I returned to the States and have lived in Columbus since then. I raised two children working as a paraprofessional in the Muscogee County School System. I have always had an interest in "What causes humans to do what they do?" Therefore, I began to take courses in Psychology at Troy University and have received a Masters of Science in Psychology and Community Counseling. Since 2006, I have been employed at WCGRH as a Social Services Provider.



What does RESPECT mean to you?

I enjoy working with the individuals on the units and hope that when they are discharged from the hospital that they can say someone took the time to talk to me, someone spent time

with me even if it was only for five minutes and someone gave me hope that in spite of everything, I can remain in recovery. That is what RESPECT means to me.

What do you hope to accomplish as a member of the RESPECT Committee?

As a member of the RESPECT Committee, I hope that I serve as an example by promoting RESPECT among my colleagues and the individuals.

Can you tell us about any upcoming initiatives from the Committee?

We the committee members are working on implementing a hospital-wide RESPECT Curriculum.

Attention All Employees

Reminder! Annual Tuberculosis Screening

All WCGRH employees must complete the Georgia State Hospital Employee Health Screening Form during the month of their birthday.

TB screening is required during each employee's birthday month.

Tuberculosis screening is conducted in Nursing Services, Building 1, Room 25.

Skin Tests are given on Monday, Tuesday and Wednesday.

Please follow these guidelines for completing the Annual Employee Health Screening:

- →If you have the skin test performed off campus, you still must return the results to Nursing Services and complete the Employee Health Screening Form.
- we will provide you will a copy of your results.
- →If you have had a positive skins test in the past, you are still required to complete the Employee Health Screening Form.
- New employees hired within three months of their birthday are not required to complete Tuberculosis screening until their next birthday.


