The Department of Behavioral Health and Developmental Disabilities (DBHDD) Division of Intellectual/ Developmental Disabilities is pleased to announce an online training course on **Person-Centered Thinking**. This e-learning course is a prerequisite for the one-day in-person course on the topic, that are scheduled from March – June 2020.

Person-Centered Thinking empowers people to live the life they choose, in the community they choose, at the level of involvement they choose.

While there are many skills that can make up person-centered approaches, the eLearning contains a series of modules focused on the following:

- The Core Concept
- Learning Log
- The Donut
- Working/Not Working
- 4+1 Questions

The training is recommended for DD Provider Organizations, Direct Support Professionals, Support/ State Service Coordinators, Planning List Administrators and Regional Office staff.

The e-learning course must be completed by the deadline that is set forth for the one day in-person course. You will not be able to enroll in the one-day PCT course without completing this prerequisite. Please see the PCT One Day Training Announcement for training details and registration deadlines.

The e-learning course is available on DBHDD's Relias Learning Management System (LMS) and should take about 3 hours to complete.
