## FY12 DD NOW and COMP Waiver Series: Financial Support Services Training

This training is designed to enhance the attendees' knowledge and understanding of Financial Support Services (FSS) as required under the Participant Direction service delivery option for the NOW and COMP waivers. Attendees will be introduced to the current FSS provider and two (2) newly enrolled FSS providers for Georgia Waiver Programs. The intended audience is primarily for individuals/representatives who currently self-direct their NOW/COMP waivers services and for NOW/COMP waiver participants who may choose to self-direct services in the future. DD family members, Advocates, Support Coordinators and Planning List Administrators are welcome to attend but must register. *This training series is NOT intended for existing and/or potential Medicaid PROVIDERS*.
