Call to Order:

Commissioner Berry called the meeting to order at 10:00 a.m.

## **Recovery Presentation**

Neil Campbell, Executive Director of Georgia Council on Substance Abuse, introduced recovery speaker Sharon Williams. Ms. Williams shared her story and lived experience, as well as the accomplishments she has made because of the programs offered to her. She is a Certified Peer Specialist and is part of the first cohort of the Forensic Peer Specialist program.

### **BHCC Initiatives Updates**

Interagency Directors Team

Berry called on Dr. Christine Doyle to give an update on the Interagency Directors Team.

Doyle, who chairs the group, is the Director of Behavioral Health Services at DJJ. She gave an overview of the team's current work and reported on:

- Annual System of Care Academy
- 2015 accomplishments
- Top 3 priorities for FY 2016
- Tele-mental health services

Transition Support and Re-entry Workgroup

Berry called on Dr. Terri Timberlake to provide an update about the work of the Transition Support and Re-Entry. Timberlake is Director of Adult Mental Health as DBHDD. She reported that:

- The second cohort of Forensic Peer Mentor Training will begin in December 2015.
- The Forensic Peer Mentor Program will be added to two additional facilities.
- Eighty individuals have been linked to behavioral health services, housing, employment, and transportation through the program.
