
Evolution of IDD Nursing


Early 1800's From Charity Structure toward Legislated Segregation

- Era of Negativity for IDD Nursing
- Placement in Education Centers
- Some Positive Outcomes
 - Identified causes of Phenylketonuria (PKU)
 - New treatments for Common comorbidities such as epilepsy, improving quality of life outcomes for people for IDD

Early 20th Century


- Training Programs for IDD Nurses Evolved
- Branch of IDD formalized in Some Countries
- Provision of Physical Care
- Transition to Development of Principals
- Living in large Congregate Settings





Latter 20th Century

- Shift toward Professionalism of Nursing
- University Study Programs
- IDD Content No Longer Seen as Necessary and Not Included in Nursing Curricula
 - Assessment
 - Treatment
 - Case Management



Latter 20th Century

- No Specialist Education
- Nurses Specializing in IDD are Poised to Establish Person Centered Approach
- Understand the Uses of Time as Therapeutic Approach
- Possess an Awareness of the Need to Adjust Language

Latter 20th Century continued...

Policy Shift in Care Frameworks

- From the Medical to the Social Model Framework
- IDD Persons Experience Increased Rate Preventable Morbidities and Mortalities
- Medical Complexity Increased with Conditions of Aging
 - Cancers
 - Metabolic
 - Endocrine
 - Neurological

Persons with Intellectual & Developmental Disabilities

- Marginalized
- Underserved
- Underresearched
- Limited impact of Emergency Planning

Driving Need For

- Tailored Approaches
- More Attention and Focus

Retrospective Review: Health Dynamics **Driving Poorer Health Status**

- Poorer Access to Competent and Accessible Healthcare
 - Specialty Areas
 - Behavior
 - Dental
- Reimbursement Has An Impact
 - Low Rates Drive Paucity
 - Quick, Infrequent, Social Determinants
- Unrecognized/Underrecognized Specialty

Retrospective Review: Outcomes Confirmed History of Medical Bias

- Factor in denying life-saving treatment
- Human Rights Violation
- Lack of Disability Guidelines for Emergency Preparedness
- Only Recent Recognition of Population as Despaired



Piecing Together COVID-19 Outcomes for IDD

Contract tracing is complex

Contract tracing algorithms not considerate of IDD dynamics

Day Programs

Shift staffing

Behavioral Dynamics of Individuals

- Experience Earlier Mortality
- More Frequently Diagnosed with Comordity
 - Diabetes
 - Obesity
 - Sensory Impairment
- Health Care Inequity

- Ineffective Communication
- Diagnostic Overshadowing
- Failure to Recognize Pain
- Failure to Recognize Health Decline
- Delays in Treatment and Diagnosis
- Lack of Preventative and Basic Health

- Decreased Access
- Lack of Coordination Among Providers
- Lack of Advocacy
- General Hospital Pathways Insufficiently Resourced

- Two thirds consider the non-verbal to have high thresholds
 - Pain Management as Risk
 - Missed Decompensation
 - Missed Indicators of Health Decline

How Many Commercials Focused On IDD Nurses During COVID-19?

Psychosocial Impact Efforts to Avoid Transmission (Staff)

- Staff Burnout
- Staff Feeling Unsupported (Individuals Challenging Behaviors)
- Increased Sleep
- Overwhelmed
- Anxiety Experienced by Frontline Staff without Acknowledgement
- Closures/Unemployment

Research Acknowledgement Legitimization

Research

- Acknowledging Peculiar Population Features
- Nurses Poised to Perform and Inform
- Confirming Higher Population Vulnerability
- Establishing Bio-Psycho-Social Approaches of Care/Support

<u>Acknowledgement</u>

- Lack of Populational National Surveillance Data Re: Impact of COVID-19
- Health Disparities Prior to Pandemic was Exacerbated After Pandemic
- Limited Access to Health Care Services
- Participate in Fewer Programs
- More Likely to Experience Polypharmacy
- Increased Rates of Hospitalization from IATROGENIC Hospitalizations
- Fragmented, Uncoordinated and Difficult to Access
