Lindsey Seizmore, outreach coordinator for the RESPECT Institute, introduced Jeffrey Alberts. He shared his life lived experiences and his struggles with substance abuse. Alberts is a proud graduate of the RESPECT Institute.

Included on the agenda was an overview of the BHCC Initiatives. Linda McCall, DCH program director gave an overview of the Interagency Directors Team's (IDT) System of Care State Plan and the continued work of the team; Terri Timberlake, director of DBHDD's Office of Adult Mental Health, shared the accomplishments of the Transition Support and Re-entry Workgroup.
