## DBHDD & DCH Announce Approval of Historic Medicaid Provider Rate Increase for NOW & COMP

The Georgia Department of Behavioral Health and Developmental Disabilities (DBHDD) today announced that the New Options Waiver (NOW) and Comprehensive Supports (COMP) waivers amendments have been approved by the Centers for Medicare and Medicaid Services. The approval of these amendments will allow DBHDD to provide historic Medicaid provider rate increases to serve individuals with intellectual and developmental disabilities.

"The approval of the NOW and COMP waivers amendments is a crucial step in enhancing the support and services available to individuals with intellectual and developmental disabilities in Georgia," said DBHDD Commissioner Kevin Tanner. "This collaborative effort with the Department of Community Health underscores our commitment to improving the quality of care and expanding access to essential resources for our community."

"This is a significant win for the state of Georgia and our continued efforts to strengthen the healthcare infrastructure," said DCH Commissioner Russel Carlson. "The rate increases will empower providers to enhance quality of services, recruit and retain skilled staff, and ultimately improve the quality of life for those DBHDD and DCH serve."

Work to actualize these amendments is currently underway. The rate increases will be retroactive to July 1, 2024. More information about the implementation of the rate increases is forthcoming.

The agencies thank Governor Brian Kemp and the General Assembly for their support and investment in these critical services. The agencies also commend the provider network, advocacy community, individuals and families for their unwavering partnership and dedication to this important initiative.

## Health Risk Screening Tool: Healthcare Plans Update



The new version of Healthcare Plans (HCP) in the Health Risk Screening Tool (HRST) application launched on April 22, 2024. Going forward the old version (v1) of HCP and templates will no longer be available.

All Providers using the in-app HCP v1 are encouraged to update all plans to HCP version 2 (v2) in HRST prior to or on the individual's next birthday.

Additionally, any Provider which downloaded the HCP templates v1 previously from HRST should begin to utilize the in-app HCP v2 in the next 12 months based on the individual's birthdate.

## **Image: Incident Reporting**

To avoid duplicate incident reports, remember you can search for previously submitted reports in Image to find out if an incident has already been reported. You can search Image by individual name, DOB, CID#, etc.



Click the link for a job aid which outlines the steps for searching in Image: **oimc\_loginmenu-search-dashboard2.pdf (squarespace.com)**. Please note that once a provider location has been deemed "INACTIVE" by the Georgia Collaborative ASO, this populates in Image. Therefore, do not select a provider location in Stage 1 of the Image Incident Report that is marked as "INACTIVE".

The Image system will display a pop-up warning when an "INACTIVE" location is selected as a Reporting or Responsible Party in Stage 1. **Click here** for an example of the "INACTIVE" pop-up message.

## **IDD Connects**

#### Avoid Getting Stuck at ISP Signature Page



When submitting an Individual Service Plan (ISP) In IDD Connects and it becomes stuck in a buffering state on the signature page, this means the size of your signature image is too big.

Shrinking or decreasing the size of your signature image to less than 4MB can resolve this problem.

## Avoid Getting Locked Out of HRST

Do you know that you need to use your IDD Connects (IDDC) user ID and password to access the HRST system?

Because the two applications share the same user access, when you change your IDDC password you need to log into HRST **immediately** with your new password, to avoid being locked out of HRST due to the wrong log-in credentials.

Logging into HRST immediately after updating your IDDC password not only keeps your log-in credentials in both systems up-to-date and synched, but it also ensures that your user access remains **ACTIVE** in HRST.

Following these steps will help you avoid being locked out and becoming deactivated due to inactivity in HRST.

# NCI-IDD State of the Workforce Survey 2023

### Deadline Extended July 31, 2024

The Division of Developmental Disabilities would like to request your assistance with the 2023 NCI-IDD State of the Workforce Survey (formerly called the Staff Stability Survey).



The National Core Indicators-Intellectual and Developmental Disabilities (NCI-IDD) State of the Workforce Survey for 2023 data began in March for eligible Providers who employed Direct Support Professionals during the 2023 calendar year. This survey gathers information about employees providing direct "hands on" services and supports, often referred to as Direct Support Professionals (DSPs). This survey gathers information on staffing levels, job stability, wages, compensation, and focuses on the DSP workforce employed between 1/1/2023 -12/31/2023.

Eligible provider agencies have received a unique link to complete this survey several times a week. The survey should be completed by the agency's Human Resources or Payroll offices. **The survey deadline is July 31, 2024.**

# Behavioral Health Paraprofessional Standard Training Requirement

IN CASE YOU MISSED IT ...

In recent communications and training, DBHDD and the Georgia Collaborative ASO provided a clarification regarding the Standard Training Requirement for

Paraprofessionals. We noted that it is not transferable between providers when a staff member changes employers.

DBHDD has received your feedback and concerns regarding this policy and understands that we have, in the past, accepted proof of training requirements from prior employers. We are working to reassess our policy and expectations and will provide a clarification in the Provider Manual for Community Behavioral Health Providers released September 1, 2024 (for an effective date of October 1, 2024).

In the interim, we have asked the Georgia Collaborative ASO Quality Review team to continue to accept proof of course completion even if it is from a prior employer. Records must be in the current personnel file and available for review.

# Behavioral Health Staff Credentialing Worksheet Tool



Providers are encouraged to take advantage of the Georgia Collaborative ASO Staff Credentialing Worksheet tool found at the link below.

The Georgia Collaborative ASO reported that "**staff credentials not supported by documentation**" was the 3rd highest billing discrepancy reason for FY23 Behavioral Health Quality Reviews (BHQRs).

In FY24 (through May 2024) "**staff credentials not supported by documentation**" is the top BHQR billing discrepancy reason.

#### How can it help?

The Georgia Collaborative ASO has developed a Staff Credentialing Worksheet tool based on the DBHDD **Provider Manual for Community Behavioral Health Providers** training requirements. This tool gives providers the opportunity to utilize the worksheet for documentation of staff credentialing. Proper utilization of the tool can offer increased compliance, potentially contributing to higher BHQR billing score outcomes.

#### How is it used?

- 1. Click on the link below to open and save the Staff Credentialing Worksheet.
- 2. Forward the Staff Credentialing Worksheet to team members who manage this process.
- 3. Click on the "Instructions" tab of the worksheet for specific utilization information.
- 4. Click on the "All Staff" tab of the worksheet for Staff Credentialing requirements.
- 5. Click on the "Paraprofessional (PP)-Supervisee/Trainees (S/T)" tab of the worksheet for requirements related to those specific staff members.
