NOW & COMP Rate Increase Virtual Meeting

Wednesday, October 16th, 2024 9:00 am to 10:00 am

DBHDD and DCH have been working diligently to implement the historic rate increases for the New Options Wavier (NOW) and Comprehensive Supports Waiver Program (COMP). These increases were approved by the Centers for Medicare and Medicaid Services (CMS) with a retroactive effective date of July 1, 2024.

DBHDD and DCH are keenly aware that the provider network is in urgent need of the additional funds; getting these funds distributed is our number one priority. While time is of the essence, we must ensure that complex system updates are made with care.

DBHDD and DCH, along with our partners Carelon and Gainwell, have made significant progress in the programming to support a successful rate implementation. Providers are now able to bill the new rates with some limitations outlined below. Additional updates are being made to support reprocessing of claims already reimbursed.

Additional details regarding system updates are being shared to keep you informed of the work ahead.

System changes overview:

To support rate increases, system changes are being made to update active authorizations and reprocess claims. The goals are trifold: speed, accuracy, and minimal administrative burden to the provider network. At this time, providers may see updates in the Georgia Medicaid Management Information System (GAMMIS), but some changes are still in progress.

1. **Provider Fee schedules**, aka Rate Tables, have been updated in the GAMMIS system for each Medicaid provider number. This rate table contains Medicaid billing codes and associated rates. At this time, providers may begin billing NOW and COMP services at the increased rates.

- DCH's update to your Fee Schedule (Rate Table) will not involve services with rates of \$1.00. Prior authorization (PA) service lines with \$1.00 unit rates will be adjusted at a later date.
- o **Important:** Steps below are still in process to make updates to the approved units and/or authorized amount on authorizations in the GAMMIS portal. Until the prior authorization Authorized Amounts are increased, Providers who bill at the increased rates are at risk of exhausting authorized amounts, particularly if the service line has an end for these months: July, August, September and possibly October 2024.
- Should the provider exhaust the dollar amount authorized, claims will be denied or receive partial payment due to "PA Dollars Partly Available." If you receive this notice on the explanation of benefits (EOB), please allow for an update of the prior authorization and subsequent reprocessing of claims.

Outstanding system changes to update prior authorizations and reprocess claims:

- 2. **Authorizations** that have an expiration date greater than the rate change (7/1/2024) must be updated to accurately account for both sets of rates (before and after the July 1 rate increase). DBHDD/Carelon has completed the programming necessary for these updates and will implement that code this weekend. Once items #3 and #4 below have been completed, Carelon will transmit updated authorizations to GAMMIS.
- 3. **GAMMIS configuration edits** must be updated by DCH/Gainwell.
- 4. Claims with dates of service 7/1/2024 and later must be voided by DCH/Gainwell.
- 5. Once the PA updates have been transmitted, DCH/Gainwell will **reprocess** voided claims.

The processes above will likely occur over a 3-week period which will impact provider payments. During this period, providers will be asked to withhold submission of new claims and adjustments to avoid impacting the update process. Following the voiding of claims, the claims will be reprocessed, and providers will receive the difference in payment.

Providers will be given notice advance notice of the exact dates so you may plan accordingly.

Program (DATEP) licensed providers when they plan to move it is required by regulation to notify HFRD. This is done by submitting the **HFRD Change of Information application**.

Notification must be made as soon as agencies are aware they will be moving as the application process is between 60-90 days before a site visit is then conducted.





Hurrican Helene Update

Due to the impact of Hurricane Helene, Governor Kemp and the Georgia Emergency Management and Homeland Security Agency (GEMA) have declared a State of Emergency for all 159 countries throughout the State.

Additionally, the Department of Health and Human Services has declared a Public Health Emergency, as authorized under section 319 of the public Health Service Act, for the State of Florida, Georgia and South Carolina.
