## Call to Order: David Glass

Vice Chair Glass recognized Mr. Owen Dougherty from the Georgia Council on Substance Abuse (GCSA) who introduced Mr. Chris J ohnson to the members of the Board. Mr. Dougherty stated Chris J ohnson had brought enormous professional and geographical diversity to the Council and his impact was deeply felt in the communities where he works to assist with the direction and consistency of GCSA strategy, commitments and goals.

Chris self-identified as a person in long-term recovery who had worked for many years in direct service to people with substance abuse challenges, at Pineland Behavioral Health and Developmental Disabilities, and Arch Recovery (men's halfway house) in Statesboro before joining GCSA. Mr. J ohnson spoke eloquently of his continued commitment to showing others that long-term recovery can be a reality.
