Recovery Presentation

Jeff Breedlove of the Georgia Council on Substance Abuse introduced Berlinda Jackson to the members of the board. Ms. Jackson is a CARES Warm Line Peer Coach with the Georgia Council on Substance Abuse. She shared her personal story of recovery.

Commissioner's Report
