Recovery Presentation

Jeff Breedlove of the Georgia Council on Substance Abuse introduced Dawn Mullinax to the members of the board. Ms. Mullinax is a CARES ED Team Lead Recovery Coach with the Georgia Council on Substance Abuse. She shared her personal story of recovery.
