Recovery Presentation

Jeff Breedlove of the Georgia Council on Substance Abuse introduced Deb Esposito to the members of the board. Ms. Esposito is an Emergency Department Recovery Coach with the Georgia Council on Substance Abuse. She shared her personal story of recovery.

Commissioner's Report

Commissioner Fitzgerald gave an update of the DBHDD hospital co-existence with COVID-19, future plans for the co-existence with COVID-19 and behavioral health COVID-19 co-existence. Commissioner Fitzgerald also provided information about Intellectual/Developmental Disabilities (I/DD) co-existence with COVID-19, an update about support coordination agencies, and internal DBHDD procedures.

Jill Mays, *director of the Office of Behavioral Health Prevention & Federal Grants,* provided a 2020 Prevention update with detailed information concerning the suicide prevention strategic plan, COVID-19 crisis, opioid epidemic, and media initiatives.

Commissioner Fitzgerald closed her report by thanking DBHDD staff and providers. She is optimistic about the pathway ahead and the agency's continued efforts.
