

Interagency Director's Team

The IDT's mission is to be a multi-agency leadership collaborative that uniquely designs, manages, facilitates, and implements an integrated approach to a child and adolescent system of care that informs policy and practice and shares resources and funding.

Issue Statement*

Children with complex needs are not getting access to the right services in a timely manner due, in part, to gaps in our collective service array and coordination of their care.

Gaps in coverage

Emergency department boarding

Out-of-home placements

Hoteling

Single-case out-of-state agreements

Case management by multi-agency state executives


Proposal for IDT Engagement

Service Design

Comprehensive residential placements, services, and supports for youth with complex needs

Health System Coordination

Streamlined coordination for youth with multiple engagements or who are in transitional age



Service Design

Purpose

- Respond to urgent needs
- Study and recommend service models for BHCC approval

Benefits

- Maximize limited resources
- Partner to share expertise and best practice
- Multi-agency approach

Examples

- Partial hospitalization
- Residential services (RBWO + Community BH Services)
- Respite
- IC3

Health System Coordination

Purpose

- Identify opportunities to streamline services and coordination for youth
- Study and process improvement opportunities for BHCC approval

Benefits

- Reduce administrative burden/duplication
- Information sharing
- Create and formalize common-sense pathways for youth as their circumstances change

Examples

- Eligibility checks for individuals with IDD
- Foster/Host home pathway and rate assessment/parity
- Transitional age youth programs
- Assessment of services available for individuals with autism
- Supportive decision-making and benefits coordination (e.g. SSI)

Proposal for IDT Engagement



Project Overview:

A coordinated and collaborative approach to analyze, recommend, and monitor meaningful solutions for complex youth.

Project Scope:

- Summarize recent improvements
- Track in-process activities
- Identify priority initiatives for annual plan

Goals:

- Recommend solutions that address system gaps
- Build shared accountability and transparency
- Maximize limited resources

Project Team:

- Interagency Directors Team
- Supported by Center of Excellence

Oversight:

- Incorporation into IDT plan and annual report
- Quarterly report to BHCC

Development of Shared Definition as outlined in HB 520

Collaborating Organizations:

- Georgia Department of Behavioral Health and Developmental Disabilities (DBHDD)
- Behavioral Health Reform and Innovation Commission
- Georgia Department of Corrections
- Georgia Department of Juvenile Justice
- Georgia Department of Community Supervision

Objective:

Develop state-level guidance to standardize terminology to facilitate communication, stream information sharing, establish shared baseline data, set measurable goals, and measure progress among state and local agencies and other entities.

Development of Shared Definition as outlined in HB 520

Standardized terminology is to be developed and proposed no later than December 1, 2023.

A single shared definition of:

- Serious mental illness
- Homeless individuals
- Recidivism
- And other related terms

Definitions will be consistently used by community services boards, corrections agencies, courts, law enforcement, and community supervision entities.

Development of Shared Definition as outlined in HB 520

No later than December 1, 2023: pilot rollout, conducted by DBHDD, at select sites to test the use of the standardized definitions and associated guidance to make any adjustments necessary to ensure it is scalable for a successful rollout statewide.

A single shared definition of serious mental illness and any other associated definitions shall be finalized and adopted by the department and the other affected state agencies no later than December 31, 2023.

Workforce Development

- Conducting two 50-State Scans to better understand the extent to which states have developed policy efforts to support building workforce capacity.
 - State Scan #1: looking at policies across the country to determine how to lessen/improve the licensing pathway for foreign trained providers.
 - State Scan #2: looking at state policies around standardizing cultural competency training.

\$8 million, five-year grant from the U.S. Department of Education.


