





- 2. Four years of general psychiatry residency
- 3. Two years of child psychiatry fellowship
- 4. Fast track: Overlap one year of general psychiatry with child psychiatry

The Fellowship also creates two additional opportunities

2. Expanded training opportunities for Psychiatry Residents

A common misunderstanding is the idea that psychiatry residencies train adult psychiatrists. They actually train "general psychiatrists"

- Residencies must provide two months of child training
- + up to 20% of outpatient time can be with children & adolescents
 - The Fellowship structure provides general psychiatry residents the opportunity to increase their skills and competence by taking electives in child psychiatry
 - The residents have 8 months of elective time in the 4th year during which they can also take child & adolescent electives
