From Legacy to Renewal: Transforming DBHDD's Hospitals

- Majority of Georgia's Psychiatric Hospital System was built between **1968 and 1972**, meaning most buildings are now **50+ years old**. Some facilities, like **ECRH-Gracewood** (opened 1921, 104 years ago) and **Central State Hospital** (opened 1842, 183 years ago), are much older.
- In the last two budget cycles, **Governor Kemp's administration and the Georgia General Assembly** have provided **unprecedented support** for facility renovations and improvements.
- **Commissioner Tanner's leadership** has laid the foundation for this confidence in DBHDD, reflected in these historic investments in our hospital system.

Historic Support

- **2023 Survey:** Comprehensive assessment of all 6 campuses → identified **\$89M** in needed improvements.
- **Extraordinary Funding:** FY2024 budget included **\$60M** to address survey findings.
- **Ongoing Investment:** DBHDD's base budget for Institutional Repairs & Maintenance doubled from **\$5M** → **\$10M annually** (recurring).
- **Continued Commitment:** FY2025 budget included **\$10M** for additional survey-related needs.

General RLR Survey Systemic Findings

- **Critical Infrastructure Needs (53%)**

HVAC, roofs, sanitary drains, electrical, plumbing, fire alarms, and security systems.

- **Safety & Cosmetic Needs (47%)**

Flooring, ceilings, paint, lighting, and signage upgrades.

- **Systemwide Priorities**

- Modern, energy-efficient lighting
- Flooring replacements for safety/durability
- Interior refreshes (walls, ceilings, trim)
- Compliance with building codes, accessibility, and safety standards
- Consistent fire alarm and signage updates across campuses

- Integrate Augusta theme into the mural on the back wall



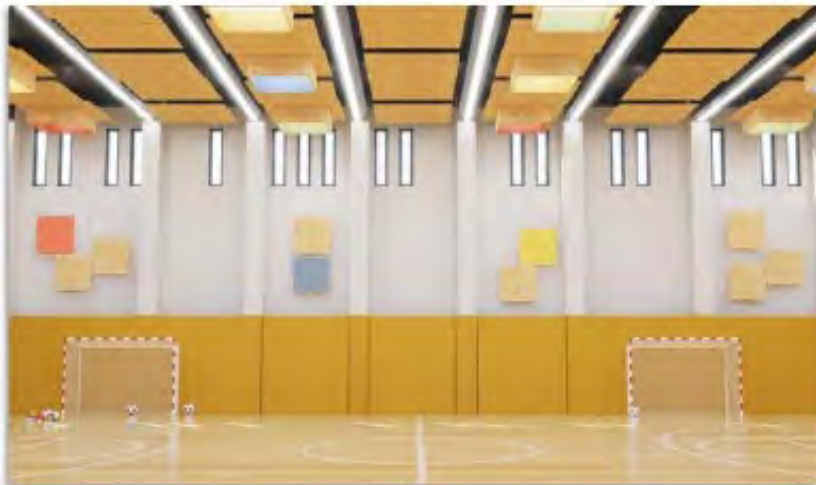

- Disperse color sound panels throughout the ceiling

- Create “sunburst” design with ceiling elements

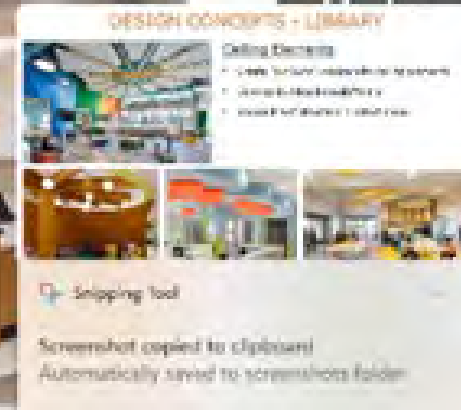


Ceiling Elements

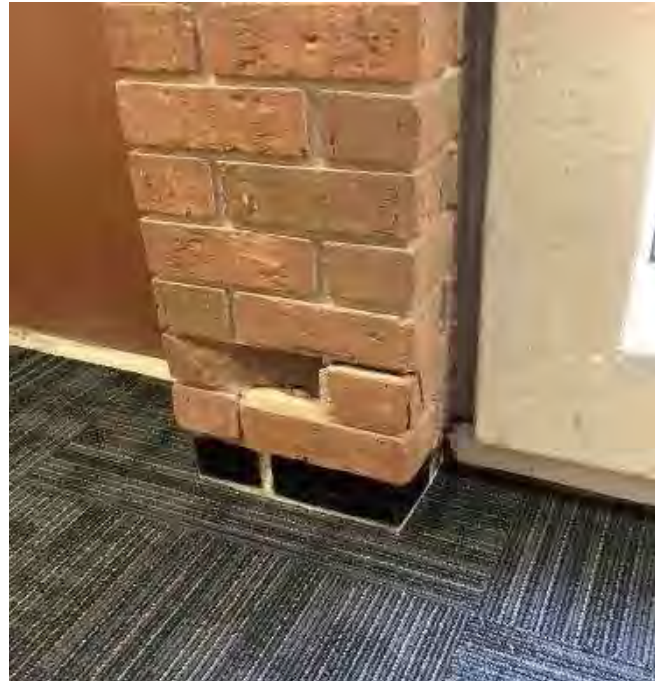

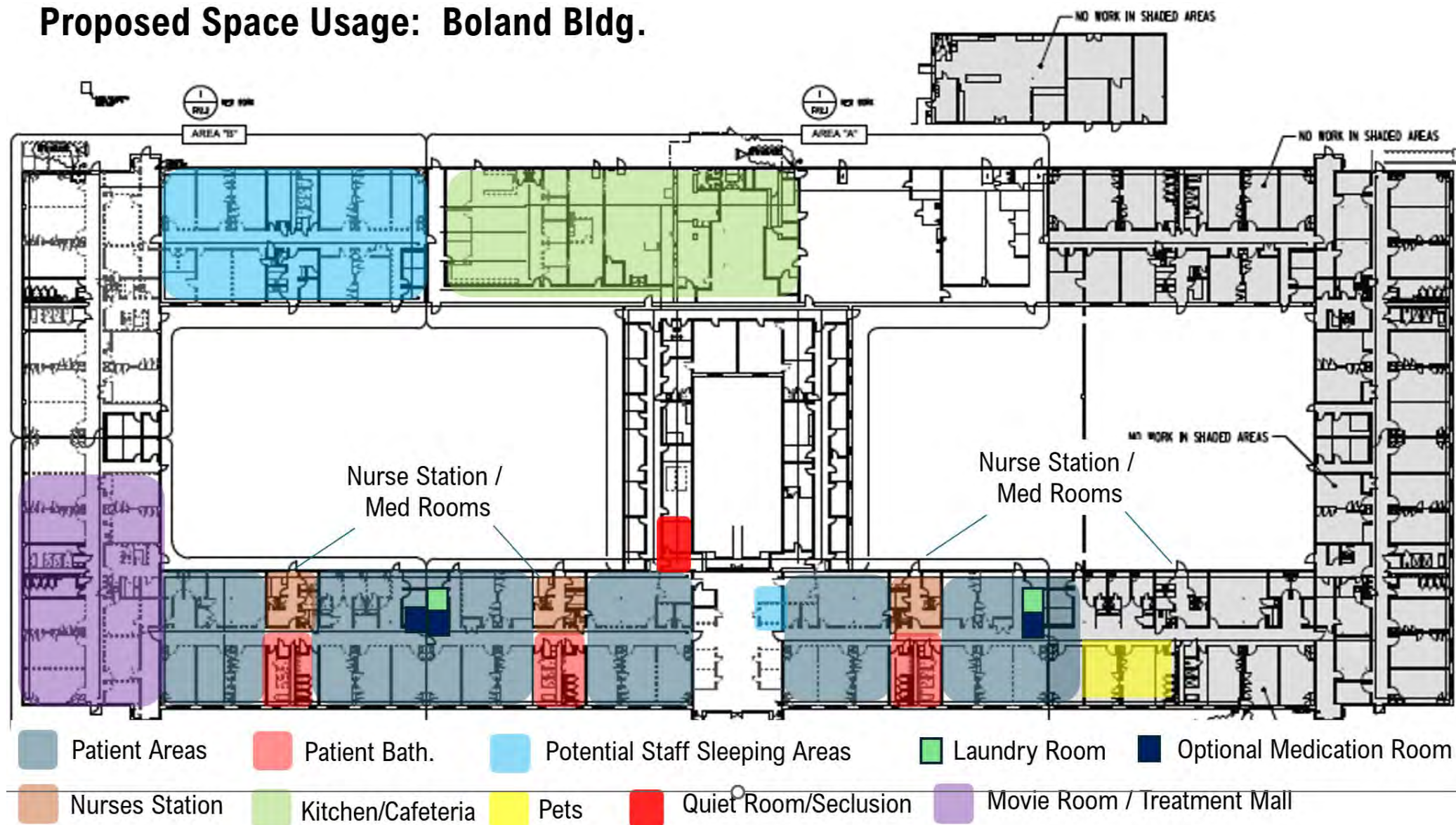

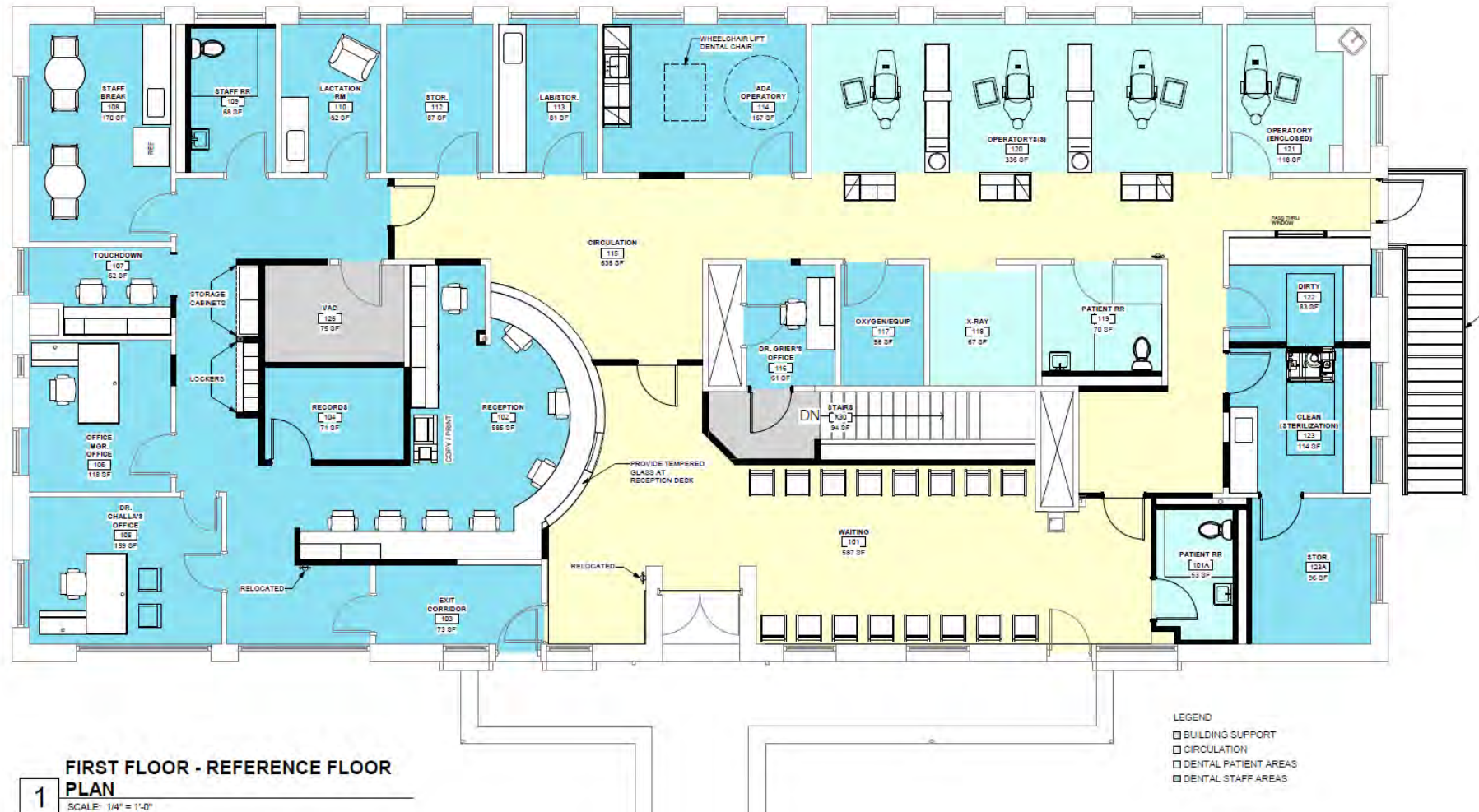

WCGRH: Ongoing Special Projects

Operation New Hope Columbus (Build 7 Renovation)

- Renovations underway since June to prepare for Operation New Hope.
- **Projected completion:** Jan 2026 (3rd week).
- **Capacity:** 30 beds.
- Staffing and program development also in progress.

Steam Conversion Project

- Multi-year project converting heating infrastructure from forced steam to natural gas.
- Includes installation of a **campus-wide generator**.
- **Projected completion:** Jan 2030.

Office of Fleet Operations – Strategic Investments

- **Total Investment FY24–FY26: \$7.1M**
- **Vehicles Purchased FY24–FY25: 69**
- **Strategic Goal refresh 20% of the DBHDD Fleet annually**

Breakdown of Investments:

- **FY24 Bond Funded: \$2M → 40 vehicles**
- **FY25 State Funded: \$360K → 8 vehicles**
- **FY25 Bond Funded: \$1.25M → 21 vehicles**
- **FY26 State Funded: \$3.5M → Vehicles TBD**

FY 2025 Update: Purchased diverse fleet to strengthen hospital and regional operations, including box trucks, wheelchair-accessible vans, passenger vans, and SUVs.

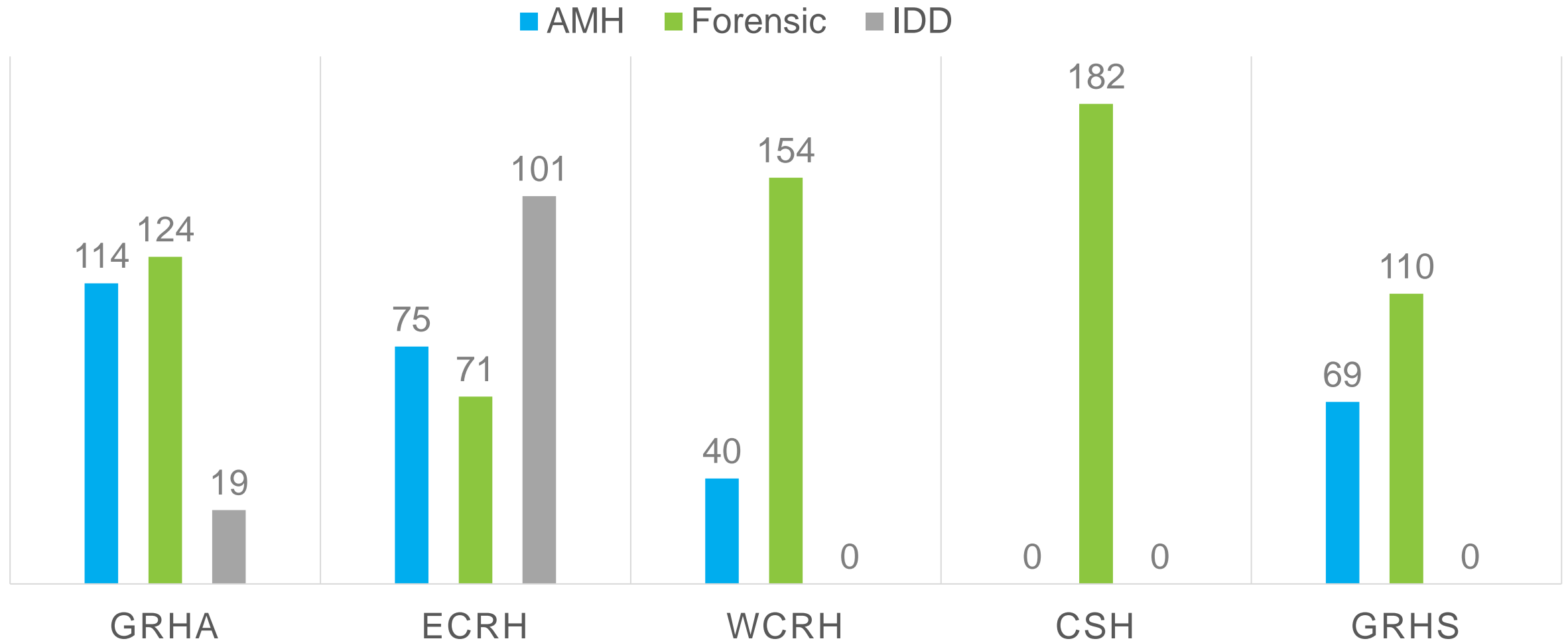

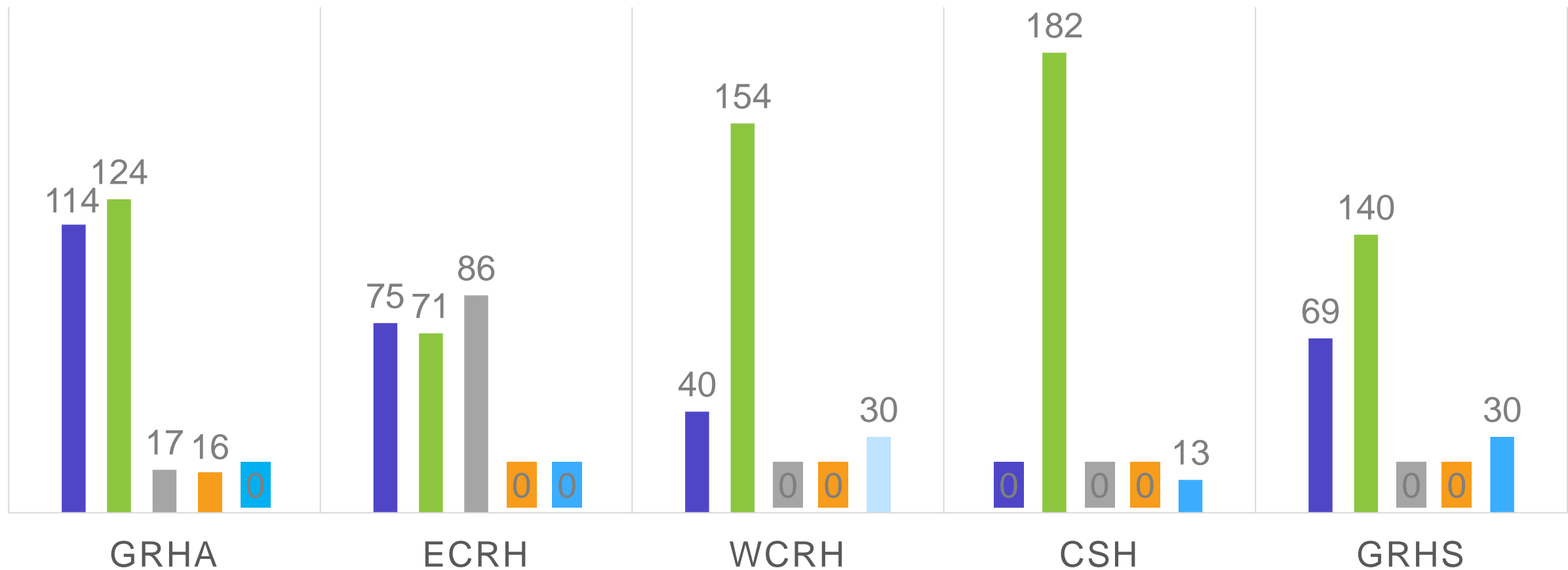
Number of Beds by Hospital 2022



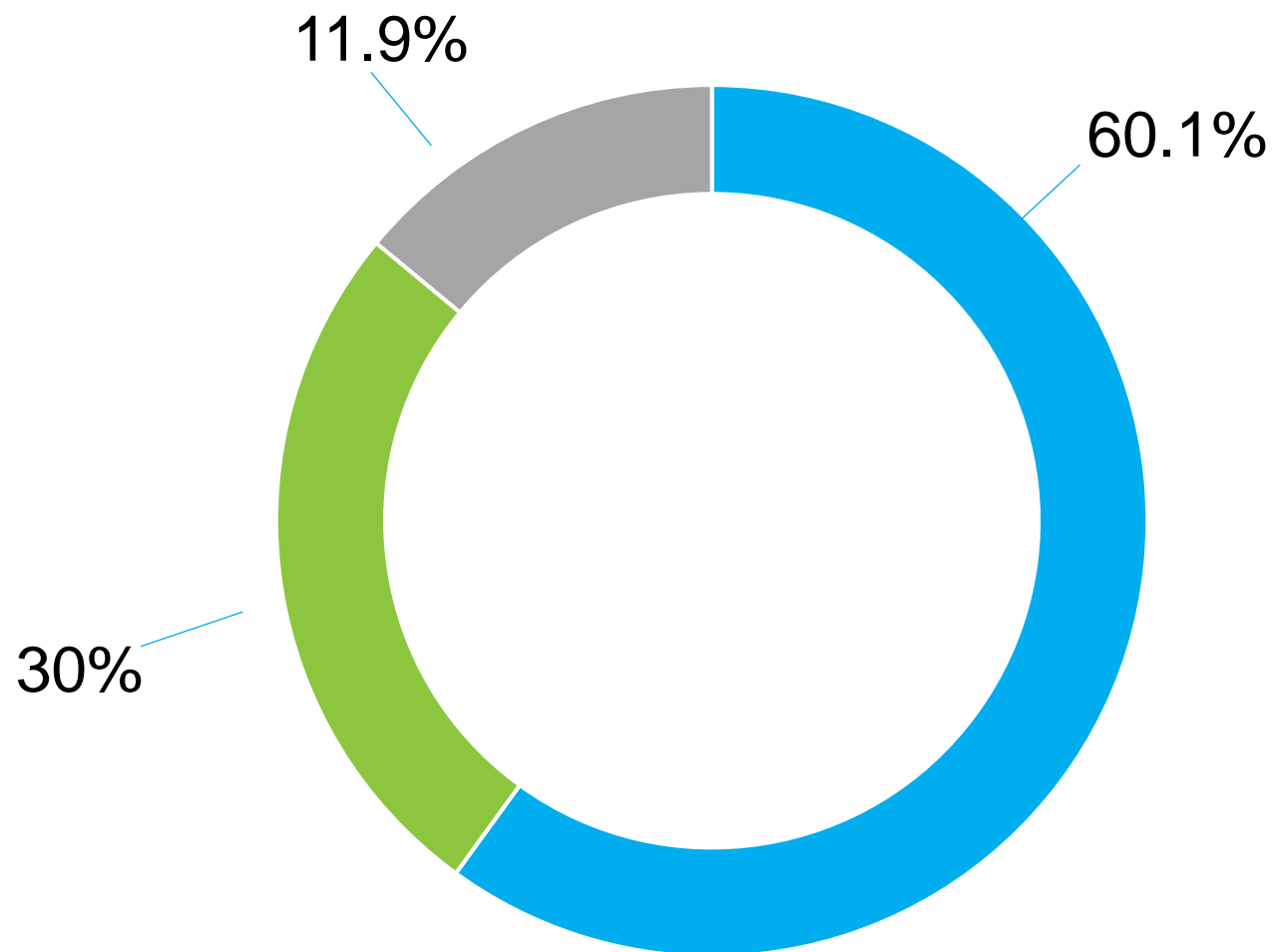
Number of Beds by Hospital 2025

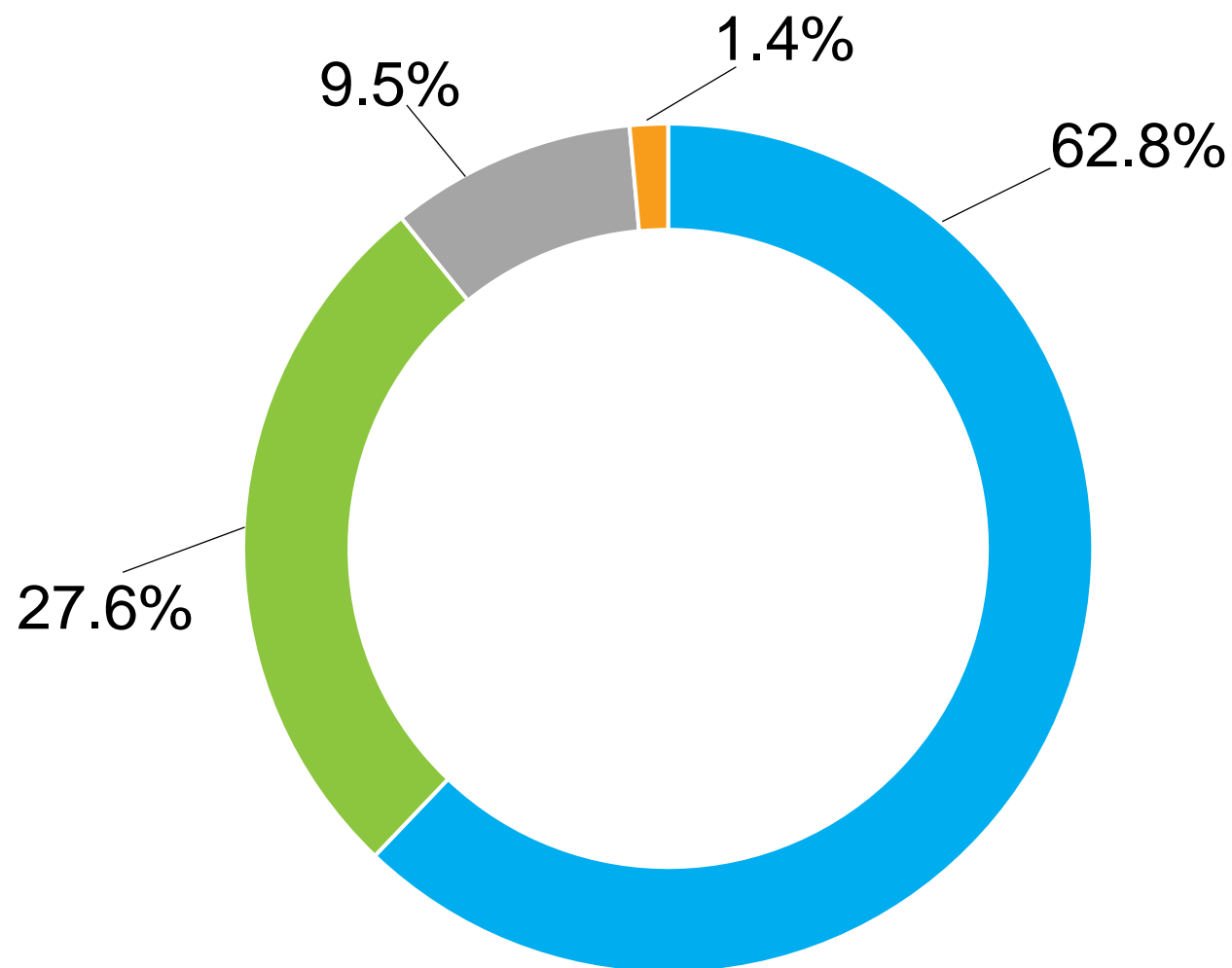

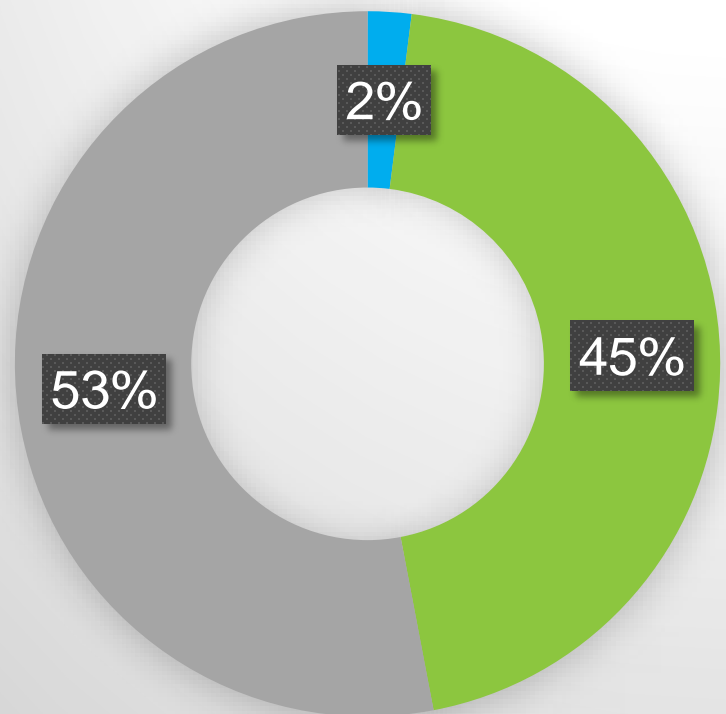

State Hospital Bed Utilization



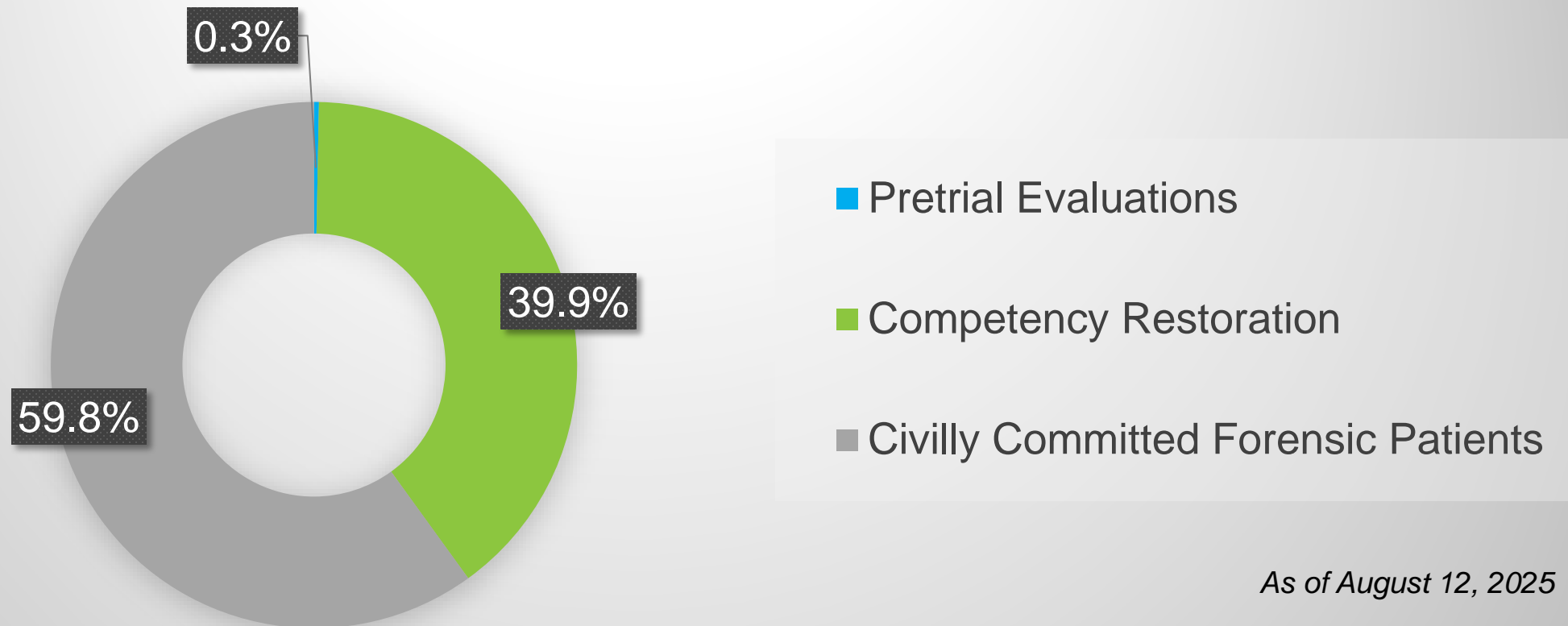

State Hospital Forensic Bed Use 2025

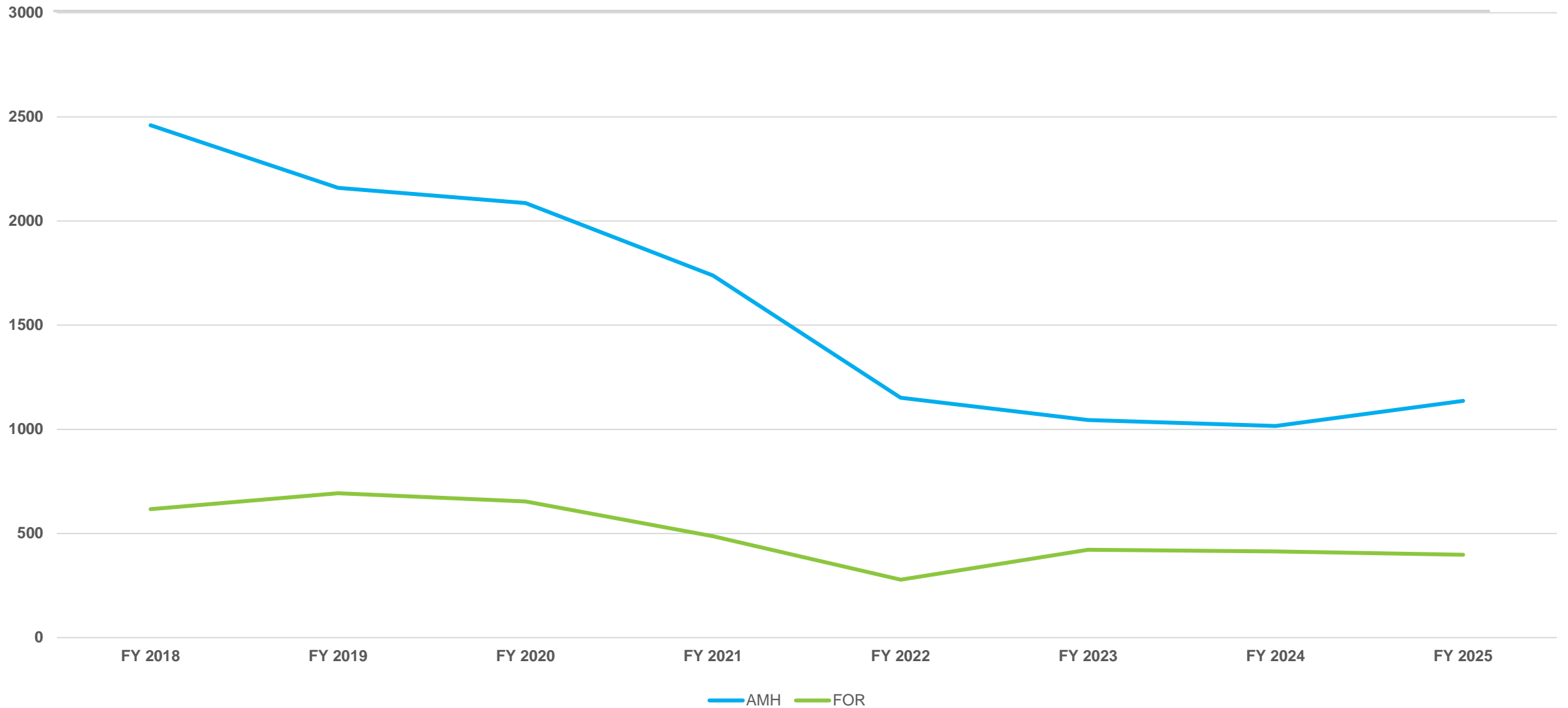

State Hospital Bed Utilization

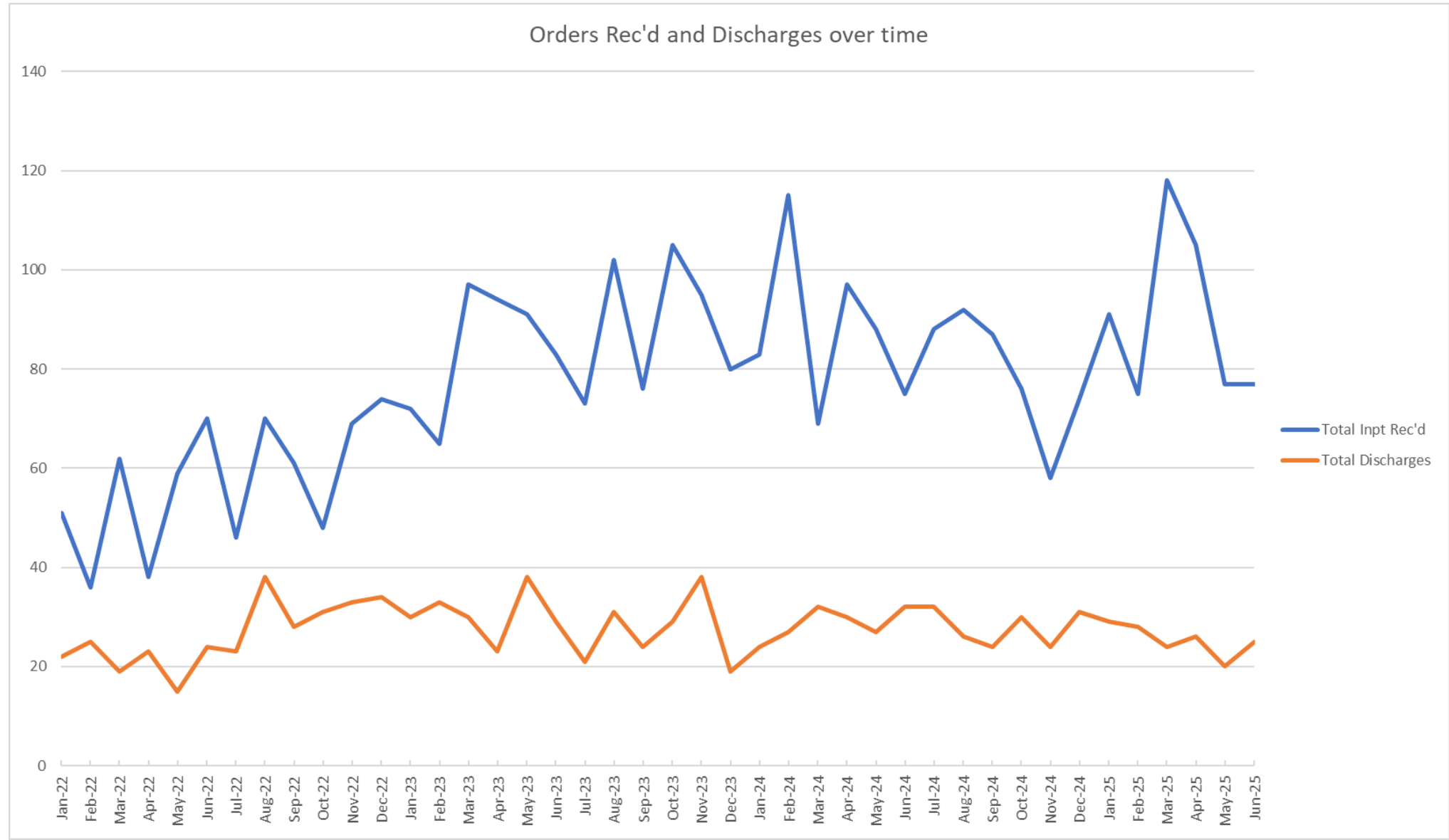

Mission Statement

The DBHDD Jail Restoration Center is committed to providing comprehensive, compassionate, and evidence-based competency restorative services to inmates who have been opined Incompetent to Stand Trial.



Admission Process

- Inmate referrals are added to the Forensic Referral Portal.
- All referrals result in a review of inmates' information prior to an admission decision being made.
- Declined inmates are referred to other programs or hospitals.
- Approved inmates are scheduled for admission.
- Standard operating procedures for admissions have been created.

Jail Restoration Center Details

- The JRC is a thirty-bed jail that houses only male inmates.
- The first inmate was admitted on January 6, 2025.
- All thirty beds were full by July 3, 2025.
- On average it has taken 63.2 days to restore inmates to competency.
- On average the length of stay is 90.02 days.
- Therapeutic Incentive Program (TIP) was implemented on July 23, 2025.

Inmates meet with the team on Monday following their admission into the Jail Restoration Center and every thirty days after that.

Community Integration Homes

- Residential services for individuals with a forensic legal status
 - Incompetent to Stand Trial or Not Guilty by Reason of Insanity
 - Referrals from state hospitals or other community placements (to prevent hospitalization)
 - Residents are under the supervision of a committing State or Superior Court
- Group home with staff available 24/7
- Assists in developing skills for more independent living
- Room, board, and watchful oversight, cost based on income
- Designed for 12 to 18-month length of stay

Community Integration Homes

- Provide an intermediate level of care for individuals with serious charges or long-term institutionalization, helping them safely transition into community living.
- Increase comfort and confidence for the courts by providing enhanced oversight and support.
- Significantly improve an individual's likelihood of securing a willing residential provider by demonstrating their ability to live in the community without reoffending.

CIH Admission Criteria

- Forensic legal status
- Over age 18
- Meets outpatient civil commitment criteria
- Diagnosed with SPMI or co-occurring MI/SA (can also have co-occurring IDD diagnosis)
- Have a payer source for medication

Exclusionary Criteria



Neurocognitive disorder that interferes with ADLs or community outings

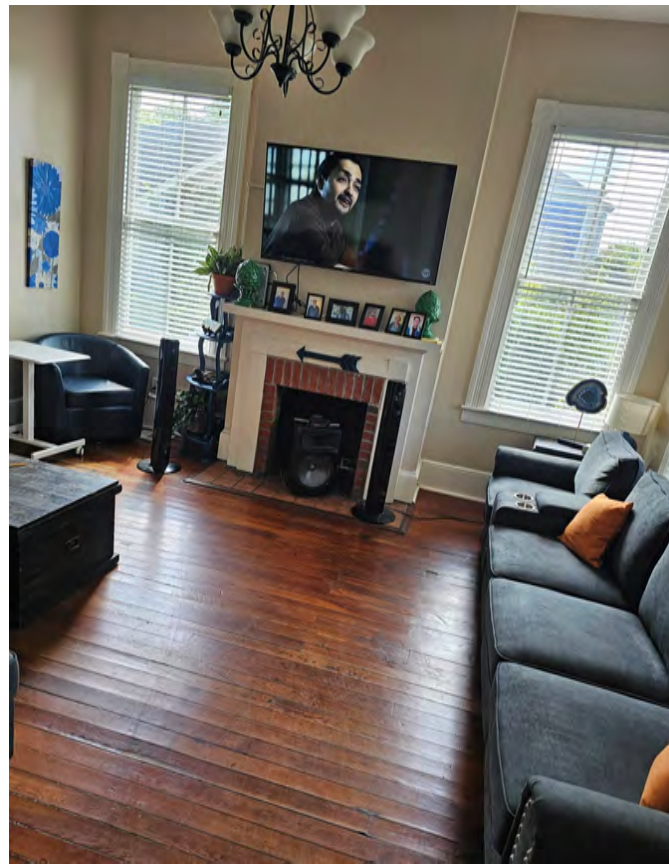


IDD diagnosis such that waiver services are more appropriate



Medical condition requiring nursing services

Courts aren't willing to authorize further stepdown

- Forensic Apartments created

Registered Sex Offenders

Balancing community integration with neighborhood acceptance

Landlord maintaining properties

Funding for personal care homes

- Not all residents attain next level of independent living

Data dashboard & real-time census tracking

Updated referral/trial process

- Increase chances of successful discharge
- Reduce length of time from referral to discharge
- Timely feedback to hospital and individual

Project New Hope

- Prepare patients for CIH placement
- Reduce length of stay at CIH or go directly to forensic apartment

Forensic Functional Assessment

- Smooth handoff from hospital to continue skill building
