Attention ProviderConnect & IDD Connect Users

The Georgia Collaborative ASO is notifying all uses of the ProviderConnect and IDD Connect systems of an upcoming change to the ProviderConnect and IDD Connect portals.

Beginning March 17, 2023, both platforms will require the use of Multifactor Authentication (MFA). Multifactor Authentication



(MFA) is an authentication method that requires users to provide two or more verification factors to gain access. This new function is important to help increase security since it means if one credential (User ID and Password) is compromised, unauthorized users will be unable to meet the second authentication requirement and will not be able to access the system. Additionally, MFA will reduce the risk of identity compromised by as much as 99.9% over passwords alone.

In an effort to prepare you for this new step, which will be required to access these systems, we will be hosting webinars and publishing reference guides between now and March 17th. Please watch for upcoming email announcements, which will include webinar registration information and training materials.

Southwestern State Hospital Campus

New Physical Address



Since the sale of the former Southwestern State Hospital Campus on April 20th, 2022, in Thomasville, Georgia, all DBHDD operations at this site have been consolidated to the Medical Services Building - 510 on the former hospital campus. Due to the transformation of the property, physical addresses were remapped and assigned to the various buildings on the site by Thomas County E-911.

Criminal History Records Check GBI Transition to Fieldprint

DBHDD has received new information from the Georgia Bureau of Investigation (GBI) regarding the transition from Thales Gemalto to Fieldprint.



Please review the message below from the GBI's Georgia Crime Information Center.

The transition of GAPS services to vendor Fieldprint is progressing. All parties continue working to ensure a successful transition from the vendor Thales to Fieldprint in a timely manner. This includes providing adequate agency training and communicating expectations for transition.

Because we understand the importance of the GAPS application to your applicant processing procedures, the original transition timeframe has been delayed. No new transition date has been confirmed.

Qlarant Resumes Collecting Community Life Information



As providers may recall, during the public health emergency, DBHDD instructed Qlarant to stop scoring Community Life in the Quality Enhancement Provider Review (QEPR). With the public health emergency winding down, DBHDD has instructed Qlarant to resume collecting information on Community Life beginning in March 2023. The data collection will use the existing Qlarant QEPR tool with which providers are familiar.

Although Community Life information will be collected, it will not become part of the overall QEPR score at this time.

During the QEPR exit interview, Community Life findings and recommendations will be shared with the provider. These findings will **not** be published in the final report which is public-facing.

DBHDD, after a review of the findings, will determine whether to begin scoring Community Life in July 2023, or continue to collect additional data on provider practices before a resumption of scoring for this focused outcome area.
