IDD CONNECTS UPDATE & IDD PROVIDER TRAINING OPPORTUNITIES



IDD CONNECTS UPDATE

DBHDD, in partnership with the Georgia Collaborative ASO, continues to work diligently to address outstanding issues and share the updates when they are released into IDD Connects. Ten (10) bug fixes and five (5) enhancements were released on March 16th by the Georgia Collaborative ASO. You will notice the following:

- 1. Modified the Individual Quality Outcome Measures Review (IQOMR) Support Note functionality to populate the contact type with "Successful Face to Face".
- 2. Modified the Clinical Review Request Support Note functionality to populate the note category and contact type based on the user role.
- 3. The system will automatically update existing records when the note category is identified as "Support Coordination".
- 4. The Individual region code will now display for assessment requests from the ISP Pending Clinical Approval page.
- 5. The ISP Service Summary will no longer duplicate the Support Coordinator detail when added after Clinical Approval.
- 6. Updated the views for existing PDF for ISP, IQOMR, and Support Notes.
- 7. The user will no longer receive an invalid email address error message when submitting the Request for Clinical Review (RCR).

Reminder, it is important to clear your web browsing history after each of these updates to ensure that you see all the enhancements that have been deployed.

Users can expect general questions submitted securely through **ProviderConnect** to be answered within five (5) business days.

When contacting customer service and/or the EDI helpdesk via phone, users can request their inquiry number to reference at a later date or to look-up in ProviderConnect. Please remember to have the following information available:

- The username, first name, and last name of the user if you have a question regarding the IDD account status, including:
 - IDD account unlock.
 - Multi-Factor Authentication reset.
 - Grant Access to User.
- The Carelon Provider ID, the Provider Medicaid ID Number, or the Tax ID (TIN) for the agency involved.
- Either the CID, Medicaid ID, or SSN and the DOB for the individual if there is a question about an individual.

*IMPORTANT NOTE: To prevent issues with signing into your account in IDD Connects, it is Imperative to update your password every 90 days. DBHDD suggests putting a reminder appointment on your calendar to assist in tracking this.

The Transformation Change workshop will be offered 12 times across the state as an opportunity to learn and gain ideas to shift HCBS from a systems-framework to a more individualized framework where the person who uses services is at the center of his/her life, determining preferences, having autonomy, and making choices which work for them. A deeper understanding of the purpose of the Rule and how to implement will create the "shift" to more person-centered practices in our daily work. Furthermore, through our better understanding of the foundation of person-centered practices in service provision, the people we work for will begin to realize their individual role and live out their dreams versus the usual, traditional manner in which services have been considered, discussed, and provided.
