Recovery Presentation

Chair Ryan introduced recovery speaker Robby Ivey from Macon, Georgia. Ivey is a recent graduate of the RESPECT Institute. She is also survivor of domestic violence and a certified alcohol and drug counselor.

DBHDD Initiatives

- DBHDD's reorganization will go into effect on July 1, 2015.
- Commissioner Berry will meet with legislators and stakeholders in Thomasville, Georgia. Berry invited board members to attend.
- *Crisis Counseling*: Bobby Cagle, Director of the Division of Family and Children Services, has asked DBHDD to assist with crisis counseling in DeKalb and Fulton counties.
- Investment in State Hospitals: Approximately 1,200 people are still being served in DBHDD hospitals. The department is investing heavily in hospital renovations, such
