Goal Analyses (1)

- Access to Services given that an individual is potentially eligible
 - Access to any services Defined as:

<u># on Short-Term Planning list</u> # on Short Term Planning list + # State Funded + # Waiver

• Access to Waiver Services – Defined as:

on Short-Term Planning list
on Short Term Planning list + # Waiver

Goal Analyses (2)

- Access to Crisis Services Among those Identified (i.e., Long-Term Planning List, Short-Term Planning List, State Funded, Waiver)
 - Assume that crisis calls indicate an area of unmet need
 - * Any calls to GCAL
 - * Multiple calls to GCAL
 - Any Calls for Urgent/Emergent Concerns
 - Multiple Calls for Urgent/Emergent Concerns

Goal Analyses (3)

- Access to Services among those receiving Waiver Services
 - Proportion of individuals authorized to receive specific services
 - Proportion of individuals actually claiming such services
 - Use of authorized services
 - Proportion of individuals who were authorized for specific services who made any claims for such services

with > 1 Claim
Authorized

* Proportion of authorized funds that were claimed

<u>\$ Claimed in 12 month period</u> \$ Authorized for 12 month Period

Types of Services to Be Analyzed

| Service Group | % of Waiver Population Authorized to Make Claim | % of Waiver Population making >1 Claim |

| Community Access – Group | 74.1% | 65.8% |
| Community Access – Individual | 34.3% | 35.3% |
| Community Living Support | 43.6% | 44.0% |
| Community Residential Alternative | 30.8% | 31.0% |
| Financial Support Services | 28.3% | 27.9% |
| Respite Services | 13.2% | 10.9% |
| Transportation | 1.2% | 1.0% |
| Prevocational Services | 8.9% | 7.8% |
| Supported Employment | 11.0% | 6.8% |

Potential Predictors of Access (2)

- Age
- Co-Occurring Disabilities/Conditions
 - o None
 - Intellectual Disability
 - Psychiatric Illness
 - Other
- ASD is the Primary Disability
 - *Note: ASD is primary in all cases except some individuals with Intellectual Disabilities*
