Yancey reported on the 8th annual System of Care Academy conference, which took place over three days and was the largest statewide multi-disciplinary gathering in the field of children's behavioral health in Georgia.

Yancey noted that the IDT is determining priority areas for FY 2016. Topics discussed were: access to services, crisis services, school-based mental health, tele-mental health, and workforce development.

Transition Support and Re-entry Workgroup

Berry recognized Terri Timberlake, Director of DBHDD's Office of Adult Mental Health, to provide an update from the Transition Care Workgroup. Timberlake reported on the areas of work that the workgroup has made significant progress on. She called on Mitzi Kellum, Program Systems Analyst with the Department of Corrections, to provide statistical information on the number of individuals who are incarcerated and have mental health issues.

Commissioner's Report

Commissioner Berry reported that he and certain staff will be visiting with sheriffs in Jekyll Island.
