Behavioral Health Core Redesign Initiative is designed to approve access, quality, efficiencies, and fiscal accountability within the community behavioral health provider network. The department plans to overhaul the behavioral provider system by using the following three components:

Procurement of administration services organization (ASO)
 The ASO will allow the department to collect and analyze data and move toward

collection of real time data to manage our higher end services.

## 2. Redesign of the network

The providers will be categorized by the following 3 Tier system.

Tier 1 -Public - CSB providers and public agencies

Tier 2 -Medicaid -providers

Tire 3 -Specialty providers

# 3. Move from Grant in-in aid process to a one twelfth performance based fee for service

The CSB"s have one year to meet the new standards that will be a part of their new contractual expectations. There will be one year of intensive technical assistance and training provided. The CSB's will remain in a special status with the department.

All three components are to achieve accountability in our public system. The technical assistance being provided along with the timeline in which the initiatives are being rolled out will result in the high quality services that Commissioner Berry has made a commitment to achieve. The legislature has allocated funds to the department that we want to be accounted for.

Commissioner Berry stated that the Tier 1 provider is responsible for

delivering comprehensive array of services.

Question:

Magelund asked, "if the CSB's are in need of additional state funds, what

is the turn-around for the CSB"s to receive funds once requested?"

Answer:

Fitzgerald said the department has put policies and procedures in place

that will instruct the CBS's how to request additional funding.

# **CONCLUSIONS**

There was no action taken.

Commissioner Berry reported on the following:

# The settlement agreement:

DBHDD is in the fifth year of the settlement agreement. This is the largest and most comprehensive settlement agreement in the United States. We are 97.3% in compliance and about 490 individuals have been transitioned into their own homes. In regards to developmental disabilities side, we have struggled with the transition process. The challenge for the last year and a half involved individuals who are very vulnerable and medically fragile.

We are currently under suspension and are only transitioning individuals on a case by case bases. The department needed to make some significant changes to the infrastructure. A joint filing with the Department of Justice, an independent reviewer along with the DBHDD made a decision to reengineer the department.

## DISCUSSION

The Department will not meet the July 1, 2015 date of the settlement agreement.

### Closure of state hospitals.

Central State Hospital will close in about 45 days. The cook building forensic unit will remain opened.

#### DBHDD Personnel Reorganization

The Department is going through a reorganization process to see how we can best align the positions with the right people and prevent duplication of work being done.

#### TRANSITION CARE WORK GROUP UPDATE

The BHCC transition workgroup continues to meet and work in conjunction with the Governor's Office of Transition Support and Reentry. The workgroup has moved forward and has spent a great deal of time focusing on the issue of stigma barriers.

Partnering state agencies have partnered with The Georgia Mental Health Consumer Network RESPECT Institute. Speakers have been scheduled to share their stories of recovery with Georgia Vocational Rehabilitation and the Department of Community Affairs.

#### Discussion

In August, DBHDD held their annual community mental health symposium for the providers in Macon Ga. Approximately 534 people were in attendance. Jay Neal, with the Governor's Office of Transition and Re-entry facilitated a session along with six community coordinators to talk specifically about the reentry initiatives that are taking place. Erica Johnson, Monica and Harris Childers from Pardons and Parole and Katrina Polk with DJJ held a session to discuss best strategies for mental health community providers and the Department of Corrections to partner and assist individuals who are transitioning back into the community.

The Forensic Peer Mentor project has received the go ahead to move forward. They have begun a series of trainings to help DOC Community Transition Re-entry Specialist deliver the supports that an individual will need to complete their entitlement benefits application upon their release from prison. Staff are being targeted at Phillips and Lee Arrandale State Prisons.

#### CONCLUSION
