Determine Key Indicators for Quality of DBHDD-Provided Services to Adults with ASD from Advisory Group

Summary of Categories for Quality Measures

- Individuals supported by DBHDD Services measures of access to services to include waiting time, match of service provided and need statement, availability, proximity, and transportation options for services.
- 2. Individual outcomes measures of community acceptance and involvement, education and employment, and quality of life for individuals with ASD.
- 3. Family satisfaction with care measures of family support, education, stress, and satisfaction.
- 4. Staffing measures of staff knowledge of autism, responsiveness to needs of clients, continuing education
- 5. Facilities providing DBHDD Services measures of proximity to clients, physical infrastructure, environmental quality, staffing, monitoring & quality improvement, and connections with the community.
