The Dartmouth Assertive Community Treatment Scale (DACTS) was completed following a visit to Pathways. Attached to this report is a copy of the completed score card. The scale is divided into three sections, Human resources: Structure and Composition; Organizational Boundaries; and Nature of Services. Each criterion is rated on a 5-point response format, ranging from 1 = not implemented to 5 = fully implemented, with intermediate numbers representing progressively greater degrees of implementation. The scale ratings are based on current behavior and activities not planned or intended behavior.
