Vice Chair David Glass welcomed everyone to the meeting.

Recovery Presentation

Jeff Breedlove of the Georgia Council on Substance Abuse introduced Renee Smith to the members of the board. Renee is a NICU Peer Recovery Coach at the Georgia Council on Substance Abuse. She shared her personal story of recovery.

Commissioner's Report

Commissioner Fitzgerald introduced members of her team to provide an update:

Madhu Gundlapalli, M.D., *deputy medical director of the Division of Hospital Services*, provided a thorough hospital update on COVID-19 coexistence in the DBHDD hospitals.

Maxwell Ruppersburg, *director of the Office of Supportive Housing*, provided a broad overview of a supporting housing 2.0 update with detailed statistical information.

Debbie Atkins, *director of Crisis Coordination*, gave an overview of the national suicide prevention and mental health crisis line: 9-8-8.

Commissioner Fitzgerald closed her report by informing the board of the continuous efforts, positive strides, and pivots being made from the DBHDD staff.

Action Items

Two action items were approved:

- 1. Approval of the February 11, 2021, board meeting minutes: Vice Chair David Glass asked for a motion to approve. Laura Whitaker made the motion, which was seconded by Jimmy Thomas. The motion was passed unanimously.
- 2. Election of Board Chairperson: General Counsel, Brenda King Woodard, called for the nomination for Board Chairperson. Jimmy Thomas nominated David Glass as Chairperson. Mr. Glass was unanimously elected as the chairperson. Mr. Glass being elected Chairperson created a Vice Chair vacancy. This being the case, Jimmy Thomas nominated Ellice Martin as Vice Chair. Dr. Martin was unanimously elected as the Vice Chair. Dr. Martin being elected Vice Chair created a Secretary vacancy. Dr. Martin nominated Jan Ligon, Ph.D., as Secretary. Dr. Ligon was unanimously elected as the Secretary. Upon accepting their election, each candidate gave kind words to serve on the DBHDD Board in their new position.
