Region 2 Priorities Update	 Relationships have been built with APS & the Office of Guardianship. Community Collaborative meetings have been taking place. In Augusta, the DA focused heavily on illegal PCH. 3 – 4 homes have been shut down. State leadership is also working closely with APS. RE: SSI – The Department is working toward easier sharing of information in order to assist with quicker benefit assignment. The Department of Community Affairs now has a unified computerized program that will help with the housing referral process. Don asked about options when someone has resources but refuses help from agencies, i.e. APS. Dawn to link him with area director. 	Dawn Peel
	Developmental Disabilities Priorities Update: No update provided.	
Public Forums Discussion	Natalie – The Burke County public forum was held at the Burke County Office Park on November 11th. Amy Stow spoke on Guardianship. Dawn Peel spoke on BH. Representatives from ResCare, AmeriGroup and other vendors presented. The Bibb County public forum was held at the River Edge Assembly on November 20 th . The forum was pretty well attended, with 20 people in attendance. Opioid treatment options and suicide prevention were discussed. Amanda – Had to re-schedule her forum due to speaker issues. Venue will be Morgan County Sheriff Training Room. Medicaid spokesperson, Drug Court Speaker, Sheriff, Pastor regarding recovery, coordinating MH/DD speakers. Lydia Aletraris – Spoke with Cat Clayton (Manager of the Opioid Use Disorder Program at Advantage) in November at a training that Advantage put on about medication-assisted treatment for opioid use disorder. At the training, Ms. Clayton spoke about the need for a public forum in Athens that would address the stigma associated with using medication-assisted treatment. Lydia said that she would like to be involved in organizing it. She suggested language as
