Means of Egress (Exits): Clear and Unobstructed

Joint Commission Standard: LS.02.01.20

Staff must have a basic understanding of means of egress. Keeping hallways and exits clear of obstructions is important for several reasons: (1) fire rescue (2) employee health and safety (3) compliance with the Joint Commission and CMS.

Fire Rescue

Compliance with the Life Safety Code is not an option, it is a requirement. This code clearly requires exits and hallways to be clear and unobstructed. If there is a fire or other catastrophic event, you need to be able to escort the Individuals as well as yourself out of the building or within a safe area as quickly and safely as possible. This cannot be done if there is equipment, furniture, etc. blocking the pathways or exits.

Compliance

The Joint Commission and CMS include enforcement of this as part of accreditation. Both Joint Commission and CMS have adopted the National Fire Protection Association Life Safety Codes by statute, which is why issues like compliance with the Life Safety Code is not an option, but a requirement.

Door Locking:

The Joint Commission expects all staff affected by door locking to understand why the locking is required and how to unlock the doors in an emergency. The provision that when locking patients behind a closed door all staff carry keys to facilitate emergency exit is rooted in patient safety. History has shown that when doors are locked and staff did not have keys readily available, lives can be lost.

Restructuring of The Governing Body at West Central Georgia Regional Hospital

The Governing Bodies have been restructured at all DBHDD hospitals. West Central held their opening meeting on November 17, 2015. The members of the Governing Body are: John Robertson, Regional Hospital Administrator; DBHDD Commissioner Frank Berry; Ms. Judy Fitzgerald, Chief of Staff; Ms. Amy Howell, General Counsel; Mr. Jeff Minor, COO; and Dr. Emile Risby, Director of Hospital Operations. Also present at today's meeting were Greg Hoyt, Office of Hospital Operations; and Lavin Gartland-Briggs, Assistant Commissioner of Public Relations.

The Governing Body refers to the entity, required by law, regulation, and standard, that is legally responsible for the conduct of the hospital as an institution and that provides for effective hospital governance, management, and budget planning.

This meeting was both productive and informative. Our senior leadership team met with the board and provided them with a detailed report of the current operations of the hospital and discussed opportunities for improvement and discussed projects and improvements that will require their assistance.

The Commissioner and the board toured the campus and were thoroughly impressed; frequently making statements about how friendly our staff was and how the environment here was so positive. The Commissioner and some of his team enjoyed some cookies and pies made by the Individuals in the treatment mall kitchen.

One major thing to come from the meeting was the board voted to approve the hospital's new mission, vision, and goals which are:



Germy gloves and scarves—Oh, my!

Winter is coming, and with that, comes colder weather. And during the cold weather season, it's common to see many runny noses, coughs, sore throats, and respiratory infections such as the flu.

Be honest: Have you ever used your scarf or gloves to wipe your nose or cover a sneeze/cough when a tissue wasn't available? Oh, my! And then with your runny nose-contaminated glove, you touch a steering wheel, doorknob, public transit railing, or seat—all the time spreading the germs to others.

Then, with your contaminated scarf that you used to cover a cough or a sneeze, you offer it to your child because she is colder than you are or hang it up in the office next to co-workers belongings. This is called cross contamination. Oh, my!

And do you take your gloves off with your teeth? If you do, the germs from your gloves are going right into your mouth. Oh, my!

Think about this—if you don't wash your hands when appropriate, like after using the bathroom, then put your gloves on, the INSIDE of the glove is now contaminated. *Oh, my!*

You wash your hands, right?

Also remember to wash your gloves and scarves on a regular basis, preferably once per week or when soiled.

There are no scientific studies that support all this, but it stands to reason that gloves and scarves are just as germy as other fabrics that haven't been cleaned—maybe more so because they are less likely to be cleaned on a routine basis. Leather and suede gloves would most likely need to be dry cleaned, and knit gloves would probably not fare too well in the washing machine. But think about how germy they are after people cough, sneeze, and wipe their noses with their gloves and scarves!

Most germs will survive for two or three days on inanimate objects—some longer. They don't have to look soiled or smell bad to be loaded with germs either!

Reminder! Annual Tuberculosis Screening

All WCGRH employees must complete the Georgia State Hospital Employee Health Screening Form during the month of their birthday

TB screening is required during each employee's Birthday month

Tuberculosis screening is conducted in Nursing Services, Building 1, Room 25

Skin Tests are given on Monday, Tuesday and Wednesday

Please follow these guidelines for completing the Annual Employee Health Screening:

- If you have the skin test performed off campus, you still must return the results to Nursing Services and complete the Employee Health Screening Form.
- If you have another job also requiring PPD Testing, we will provide you with a copy of your results.
 - If you have had a positive skin test in the past, you are still required to complete the Employee Health Screening Form.

<u>Please Note: If Annual Tuberculosis is not completed within your birth month, Employee cannot work until the screening is completed.</u>
