FY12 Health Risk Screening Tool (HRST) Training: Informational Session for Support Coordinators

This informational session is to address any and all on-going issues with the Health Risk Screening Tool (HRST) as it relates to quality and validity.

This training is specifically for **Support Coordinators and Support Coordination Administrators** who use the information from the HRST and/or have questions about the HRST. The goal of this session is to be informational and to provide troubleshooting strategies. This is not a typical HRST training class. The presenter for this training will be Dr. Erin Mathews, BS, DC, a chiropractic physician who has 14 years experience with the Health Risk Screening Tool and has been providing clinical support services and training in Georgia since 2006. 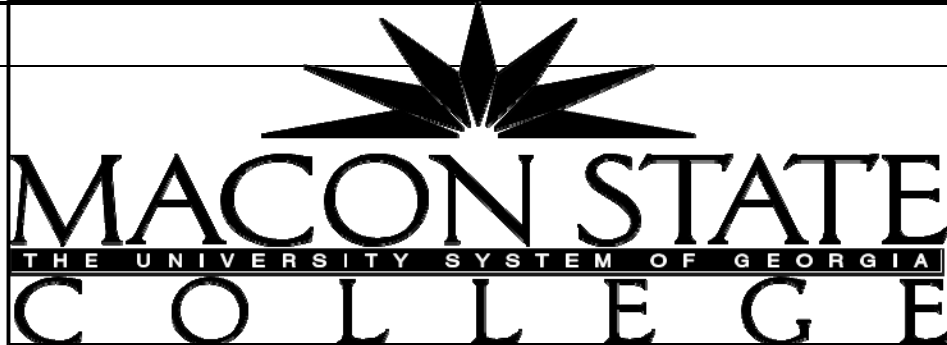
