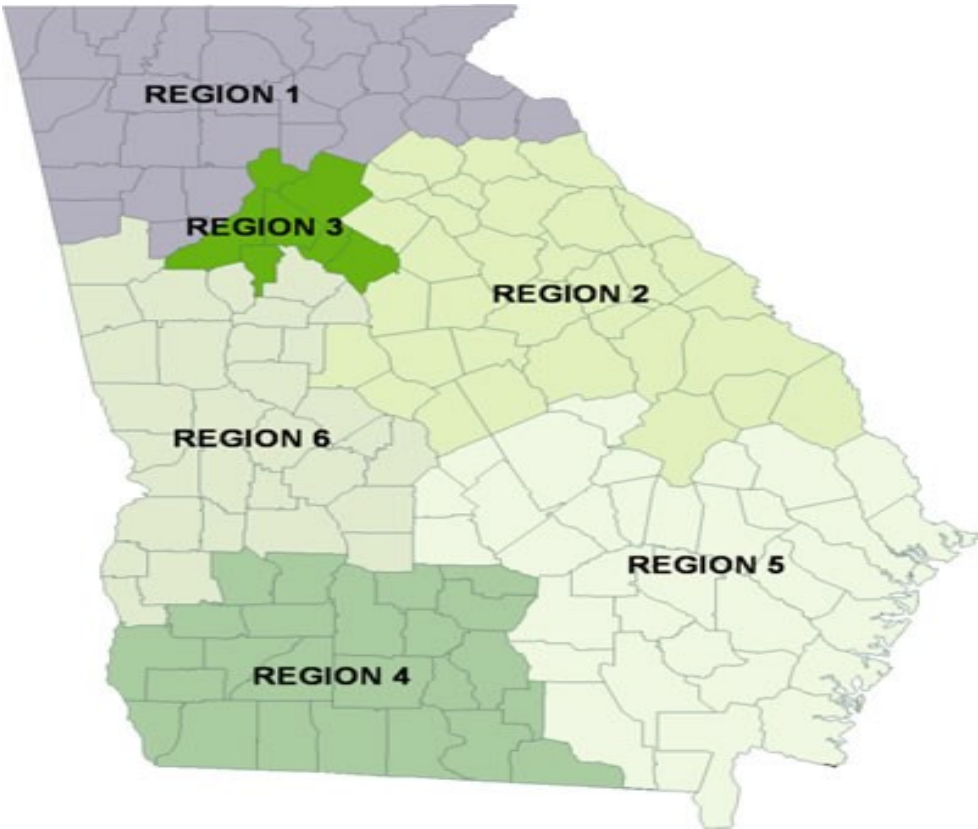

## Adult Mental Health Services

Recovery based programs are available and accessible across the state. The Georgia Department of Behavioral Health and Developmental Disabilities (DBHDD) is working to ensure that every area of the state receives adequate resources and that basic services are accessible to everyone in need.

Many individuals approach the state service system looking for help. State supported services are aimed at those with a diagnosed mental illness and with a level of functioning significantly affected by the mental illness. The service a person receives depends upon a professional determination of need and the services and other community resources available.

### **Community-Based Mental Health Services**

Community Services are provided through contracts with private, for-profit, nonprofit, and quasi-public agencies under contract with DBHDD through the regional offices. Consumer choice is a value that is embraced throughout the system and is fostered through the development of different kinds of provider agencies including consumer operated agencies. These organizations vary in scope of services provided including those services that address more individualized needs.

## **Current Adult Mental Health Special Initiatives**

- 1. Disaster Mental Health Services:** The Department of Behavioral Health and Developmental Disabilities (DBHDD), in accordance with the Georgia Emergency Operations Plan Emergency Support Function (ESF) 8 Public Health and Medical is responsible for behavioral health and community disaster mental health services during times of emergency, disaster, or terrorist strike. Maintenance of continued behavioral health services during emergencies and disasters is essential. In addition, DBHDD is required under ESF 8 to offer mental health care to disaster survivors, bystanders, responders and their families and other community caregivers. DBHDD has a comprehensive and coordinated plan for preparation, prevention, response, recovery and mitigation of behavioral health and community disaster mental health services for Georgia. 2. **Pre-Admission Screening and Resident Review (PASSR)**: Medicaid regulations require states to maintain a PASSR program to screen nursing facility applicants and residents for serious mental illness. The purpose of PASSR is to ensure that nursing facility (NF) applicants and residents with mental illness and/or mental retardation are identified, admitted or remain in a NF only if they can be appropriately served in the NF and provided with needed services including specialized mental health and mental retardation services.
  
3. **The Projects for Assistance in Transition from Homelessness Program (PATH)**: Homeless Outreach teams located in Atlanta, Augusta, Columbus, and Savannah go to the streets and homeless shelters to identify homeless individuals with mental illness, engage them in treatment and connect them to mental health services and mainstream resources needed to end their homeless cycle. 4. **SSI/SSDI Outreach, Access and Recovery (SOAR)**: SOAR is national project funded by the Substance Abuse and Mental Health Services Health Administration (SAMHSA) that is designed to increase access to SSI/SSDI for eligible adults who are homeless or at risk of homelessness and have a mental illness and/or co-occurring substance abuse disorder. Using a 3-pronged approach to Strategic Planning, Training and Technical Assistance (TA), the SOAR TA Center coordinates this effort at the state and community level.
  
5. **Limited English Proficiency and/or Sensory Impairment (LEPSI)**: DBHDD is committed to ensure that LEPSI consumers and family members have meaningful language access to all services conducted or supported by DBHDD. A regional Language Access Coordinators in each regional office is trained to assist LEPSI consumers and providers in accessing language assistance through a qualified language vendor. Please contact your Language Access Coordinator at the Regional Office if you have any questions or concerns regarding access to free interpreting services.



## How to Access Adult Mental Health Services

### **Georgia Crisis and Access Line (GCAL) 1-800-715-4225**

Georgia offers a statewide toll-free call center for consumers to access services. The call center operates 24/7 and has the capacity to screen and assess callers for intensity and service response.

- ❖ **Language Assistance:** Telephone interpreting services are provided to callers with limited English proficiency.
- ❖ **Emergencies:** Individuals determined to be in immediate danger are “warm transferred” to the local 911 service in the area where the consumer is located. Call center staff do not leave the call until they have confirmation that 911 responders are on site with the caller.
- ❖ **Crisis Assistance:** Individuals in need of crisis management will receive 24/7 mobile response to assess the situation, de-escalate the crisis, consult and refer with post crisis follow-up to assure linkage with recommended services.
- ❖ **Routine Service Access:** For consumers with less intense needs, the call center staffs are able to offer consumers choice of providers and to schedule appointments for services. Consumers are able to specify the distance they are willing to travel and the call center identifies service providers within that proximity to the individual’s zip code location.

About Contacting Service Providers Directly: Consumers may choose to contact local providers directly for services. The “no wrong door” philosophy is still an important value in the Georgia system. In addition to the GCAL call center, the website contains a resource database on service providers and contact information throughout the state. Using your zip code, you can identify a provider in close proximity.

## Core Services

The service a person receives depends upon a professional determination of need and the services and other community resources available. Community services are provided through contracts with private, for-profit, nonprofit, and quasi public agencies under contract with DBHDD through the regional offices. - Diagnostic Assessment

- Psychiatric Treatment

- Group Counseling Services
- Family Counseling Services

## Assertive Community Treatment

This intense community based service uses a multi-disciplinary team approach to provide comprehensive treatment and support to individuals with severe and persistent mental illness, who are unable to successfully live in the community without this intense level of support and treatment. A multi-disciplinary team comprised of a licensed clinician, psychiatrist, registered nurse, substance abuse counselor, vocational specialist, paraprofessional(s) and a certified peer specialist work in close collaboration with the individual to provide comprehensive treatment and support services that support achievement of the individual's recovery. For eligible persons, community-based interventions are rehabilitative, intensive, integrated and include assessment, medication management, crisis intervention, individual, family, group counseling, housing assistance, vocational support and peer support.

## Case Management

This service addresses the needs of individuals diagnosed with mental illness who need assistance in order to successfully implement their Individual Recovery Plan (IRP) and maintain recovery in the community. Case Management provides environmental support and care coordination considered essential to assist the individual with improving his/her functioning, gaining access to necessary services and creating an environment that promotes recovery as identified in his/her Individual Recovery Plan (IRP).

A case manager works in close partnership with the individual, physician and other recovery – supporting services to deliver interventions in the individual’s home and community to assist the individual with:

1. Developing natural supports to promote community integration
2. Identifying service needs
3. Referring and linking to services and resources identified through the service planning process
4. Coordinating services identified on the IRP to maximize service integration and minimize service gaps
5. Ensuring continued adequacy of the IRP to meet the individual’s ongoing and changing needs

## Community Support Team

This service addresses the intensive need of individuals with severe and persistent mental illness living in rural areas of the State who have a history of multiple inpatient hospital admissions or extended stays or from multiple discharges from crisis stabilization unit(s) or discharged from correctional facilities or other institutional settings and are difficult to engage in treatment. CST is a restorative/recovery focused intervention to assist individuals with gaining access to needed services, self – managing illness, developing independent community living skills and achieving stable living arrangements.

A multi-disciplinary team comprised of a licensed clinician, registered nurse, paraprofessional(s) and a certified peer specialist work in close collaboration with the individual, physician and other recovery – supporting services to ensure continuity of care without disruption and enable the individual to become as independent as possible. Members of the Community Support Team deliver the majority of interventions in the individual’s home and/or community which include nursing services, symptom management, medication administration, referral & linkage, care coordination, individual counseling, skills training, relapse prevention and crisis planning.

## Crisis Respite Apartments

This service offers a brief period of crisis respite for an individual needing a supportive environment:

1. When transitioning back into the community from a psychiatric inpatient facility, Crisis Stabilization Unit (CSU) or 23 – hour observation area or;
2. When preventing an admission or readmission into a psychiatric inpatient facility, CSU or 23 – hour observation area and can be safely served in a voluntary community – based setting. Crisis Respite services include individualized engagement, crisis planning, linkage to treatment and other community resources necessary for the individual to safely reside in the community and transportation assistance when needed to access appropriate levels of care. A typical period of crisis respite is 14 days or less but may be provided for up to 30 consecutive days.

A Behavioral Health Crisis Service Center (BHCC) provides 24/7 walk-in access to psychiatric crisis assessment, intervention and counseling to support individuals experiencing a crisis, substantial, overwhelming stress or change in behavior that severely impairs functioning and/or causes increased personal distress. Interventions are designed to prevent CSU level of care or psychiatric hospitalization. Interventions also include temporary observation, mobilization of natural support systems; successful linkage to appropriate levels of care for adults experiencing crisis situations which may include a crisis stabilization unit or other services deemed necessary to effectively manage the crisis and to arrange transportation when needed to access appropriate levels of care.

## Crisis Stabilization Units

A Crisis Stabilization Unit is a community-based alternative to and/or diversion from psychiatric inpatient hospitalization offering psychiatric stabilization and detoxification services. This program provides medically monitored psychiatric, short-term treatment services, for the purpose of psychiatric stabilization and substance detoxification. Services may include:

1. Psychiatric Medical Assessment
2. Crisis Assessment, support and intervention
3. Medically monitored residential substance detoxification (at ASAM Level III.7-D)
4. Medication Administration, management and monitoring
5. Brief individual, group and/or family counseling
6. Linkage to other services as needed

## Intensive Case Management

Intensive Case Management is a service that addresses the needs of individuals with severe and persistent mental illness who have a history of multiple psychiatric hospital or crisis stabilization unit admissions/extended stays, other in institutional settings, or history of incarceration as a result of mental illness, and are difficult to engage in treatment. Intensive Case Management provides environmental supports and care coordination considered essential to assist the individual with improving functioning, gaining access to necessary services and creating an environment that promotes recovery as identified in his/her Individual Recovery Plan (IRP),

Intensive Case Managers maintain small caseloads and work in close partnership with the individual, physician and other recovery supporting services to ensure continuity of care without disruption and enable the individual to become as independent as possible. Intensive Case Managers deliver the majority of interventions in the individual's home and/or community to assist the individual with

1. Developing natural supports to promote community integration
2. Identifying service needs
3. Referring and linking to services and resources identified through the service planning process
4. Coordinating services identified on the IRP to maximize service integration and minimize service gaps
5. Ensuring continued adequacy of the IRP to meet the individual's ongoing and changing needs

## Mobile Crisis

Mobile Crisis is a service that provides community based face to face crisis response 24 hours a day, seven days a week to individuals in an active state of crisis. Mobile Crisis Response Service offers short term behavioral health intervention for persons in need within their community who are experiencing significant psychiatric distress and may be unable to successfully maintain stability. This service provides interventions to persons who may be in crisis in their homes or current place of residence or other community settings. Community settings may include but are not limited to; homes, schools, hospital emergency departments and social service settings. Interventions include a brief, situational assessment; verbal interventions to de-escalate the crisis; assistance in immediate crisis resolution; mobilization of natural support systems and referral to alternate services at the appropriate level. This service includes a post crisis follow-up to ensure linkage with recommended services.

## Psychosocial Rehabilitation

This service consists of rehabilitative skills building, the personal development of environmental and recovery supports considered essential in improving a person's functioning learning skills to promote the person's self access to necessary services and in creating environments that promote recovery and support the emotional and functional improvement of the individual. The service activities of the Psychosocial Rehabilitation-Individual include:

- Providing skills support in the person's self articulation of personal goals and objectives
- Assisting the person in the development of skills to self manage or prevent crisis situations
- Individualized interventions in living, learning, working and other social working environments

This service is provided in order to promote stability and build towards functioning in the person's daily environment. Stability is measured by a decreased number of hospitalizations, by decreased frequency and duration crisis episodes and by increased and/or stable participation in community/work activities. Supports based on the person's needs are used to promote recovery while understanding the effects of the mental illness and/or substance use/abuse and to promote functioning.





## Supported Employment

This service is available to eligible individuals who express a desire and have a goal for competitive employment in their Individual Recovery Plan and who, due to the impact and severity of their mental illness have recently lost employment or been underemployed or employed on a frequent or long term basis. Currently, there are 22 Supported Employment providers throughout the state. Services include supports to access benefits counseling; identifying vocational skills and interests; and developing and implementing a job search plan to obtain competitive employment in an integrated community setting that is based on the individual's strengths, preferences, abilities and needs.
